The committee did have to leave and buy 15 bags of ice because of the inability of the ice truck to keep up with our ice sales. There were some bags of ice left over on the 5<sup>th</sup> of July, however, the ice machine was tore up by the wind and any left over ice melted on the way home from the campout.

### **CAMPOUT DONATIONS**

There was a big stink as to the committee reserving the campgrounds earlier than July 2. There were 3 extra days that the campout committee paid for the campground at \$100 per day for a total extra cost of \$300. The three extra days were a big hit with many people. Several people showed up the day the campground opened. Since these extra days were such a big deal to some, the members of the committee that were there early, made sure that we went around and asked for donations from those who showed up early to cover the extra costs. The total donations that we received for the three extra days was \$238.81. We would like to thank those who contributed to this. So the committee really only paid out \$61.19 for those three extra days. We hope this solves some of the crap that came up about this whole issue.

The totals for each nights auction and raffles are not as detailed as years in the past. Each night that we had an auction/raffle, Tim and I found that we were the only ones there keeping track and running the things. Tim had to write down the auctions on sides and tops of boxes, so I had to come home and do them all on the computer. The lists are attached to my report. Although it seemed like what could go wrong did go wrong, with the wind, Tim's plight, and Cindy cracking her knee cap on Friday night; it seems as though things went better than could be expected under the circumstances.

Tim K. provided 3 tents and 3 nights of DJ service for the same price, not to mention the tents that were tore up due to the wind, without asking for more money. I'm sure there will be some who will complain about this issue, go ahead and complain, but as treasurer (and Tim K's spouse), I feel that the committee got a hell of a deal.

**Mid-America Region of NA  
Regional Delegate Report  
World Service Conference 2000**

Dear NA Family,

This report is bitter sweet for me. Bitter because it is my last report as the RD for the best region in NA. It is sweet because I get one more opportunity to serve my region and to share with you what was given to me at the WSC. Too blessed to be depressed. Thank you all for allowing me to serve you as your Alt. and RD. I don't believe anyone can attend the WSC without being changed hopefully for the better. I have also been asked to keep this report shorter than in past years which should be fairly easy to do as there wasn't near as much business to attend to and there was less time spent in session.

Like last year this conference was a study in contrast to all the previous conferences I've been allowed to attend including the 99 WSC. For one thing, there was only one major temper tantrum by an RD the whole week and there were only a total of 71 motions which was way down from previous years.

An NA History workshop was held the day before the conference actually started. 15 or 16 members who first came to NA in the 50's and 60's shared their experience, strength, and hope with us. There was in excess of 520 yrs. combined clean time in this group of individuals and what they shared has been recorded so we don't lose this precious resource. I am a firm believer that to truly appreciate the fellowship of NA it's very important to know our history. To see how we started and how we have grown into a worldwide fellowship. These folks also appeared to have that "cut the crap and work the steps" kind of recovery which is the very essence of freedom from active addiction "The NA Way." They seemed very kind, humorous, open minded, and spiritual in their sharing. My understanding is the next task in gathering historical information is to get the East Coast early NA members together for sharing sessions.

That same evening these early NA members were the quest speakers at the Sat night speaker meeting. Unfortunately for myself I had to miss the meeting due to food poisoning or it's equivalent. It's been awhile since I had to worship the porcelain alter or sleep on a bathroom floor. Kinda reminded me of the pre-recovery days where that was a frequent occurrence. Enough of that. We did, however, get a copy of the speaker tape for auction and raffle. It is a great tape and I believe it can be ordered from NAWS.

The following day the conference officially opened with an orientation session. George H., co-executive director of the world service office, addressed the conference. For those of us who didn't know, George suffered a stroke in Feb. and remains partially debilitated. It was a shock for me and a very sad moment. George is truly one of the most dedicated individuals I have ever met and has served our fellowship unselfishly for several years. He has been and remains an inspiration to all who know him. It was announced that Floyd B. passed away from his cancer this past year. Floyd was also an inspiration to all who knew him and will be sorely missed.

The Sunday orientation session then broke up into small group sharing sessions. Topics were: what is your personal goal for this conference and what do you as a conference participant add to the conference. These type of group discussions help get the participants focused on why we were there and that it is a privilege to serve the fellowship. The sharing sessions seem to raise the spiritual consciousness of the participants and puts everyone on a level playing field.

We then moved back to the main meeting room and were served cake and given a medallion in celebration of the 25<sup>th</sup> anniversary of the WSC. Incidentally, several of the Sat speakers attended the 1<sup>st</sup> WSC. I have made copies of the minutes of the 1<sup>st</sup> WSC for each of the RCMs and RSC trusted servants. It is interesting to note the budget in 1976 was around \$2200. and that NA still operated in the red. The budget for the next 2 yr. Conference cycle is approx. \$12,000,000. My how times have changed and how we have grown. The medallions that were made for this 25<sup>th</sup> anniversary are collectors items and are not likely to be reproduced. We were lucky enough to get a few extra for raffle and auction items.

Following the opening ceremonies, the first roll call was taken with a total of 108 voting participants with 91 regions present. After some discussion the rules of order and minutes from the 99 WSC were both adopted. There was an amendment to the election procedures and then they were adopted.

Seating of new regions came next. Guatemala and the Baja-son Regions were seated by 2/3 voice vote. The conference then adjourned for the evening. There was a board meeting and open forum with the board from 8:30 to 11:00 that evening which actually got out around 11:30 or 12:00. During this session the WB discussed new motions 26-46. After the WB discussion a few RD's who had resentments over how the board had responded to their motions addressed the board and aired their resentments. This was really a good thing because differences were resolved and did not have to come to the conference floor which helped to keep the conference from disintegrating into a verbal blood bath as it has in previous years. We're learning folks. Slowly, but surely, we're learning. There was also a lot of praise for the work the WB has put in over the past year and much discussion about how information was going to be gotten from the early NA members on the East coast. The WB indicated NAWS would be trying to arrange additional interviews and meetings with both the East and West coast contingents of 50's and 60's NA members.

Monday began with discussion of Motion #1. The non-English speaking countries showed little support for the suggested fellowship evaluation for changes in literature and indicated they believe it is a USA fellowship issue. They stated it puts them at a disadvantage both because they would not understand the changes and it would put translations back even further. They were supportive of some new pieces on sponsorship but did not seem to feel they needed to be in the basic text. For those of us who didn't know, some non-English countries already put their own personal stories in their versions of the basic text. And no, it is not a violation of copyright laws as the WSC has previously given consent to do so.

We then moved into old business (IE CAR motions). A motion to postpone motion #1 definitely until WSC agreed it applies only to the English speaking version of the basic text was introduced then amended to lay on the table Motion #1.

This amended motion was defeated and Motion #1 passed. Since new information was introduced concerning this motion, Betty and I discussed the option of changing our vote but decided that this motion concerns only an evaluation process and cast our vote in the affirmative as determined by our regional fellowship input. At this point I will state that on the following Sat. the budgeted cost of the literature evaluation over the next 6 years is nearly \$600,000. Had we known what the financial impact was budgeted to be this motion may not have passed. Motion #2 passed as well with option B getting the nod (IE having the evaluation survey ready to send out to the fellowship in 2004). In light of this selection and evaluation timetable it will be at WSC 2006 before NAWS knows what, if any, changes the fellowship will want for our Basic Text and Little White Book. Motions 3, 4, and 5 all passed and we broke for lunch.

The afternoon session began by discussing what outcomes we wanted from our small group discussions. Many delegates wanted to see some tangible results from these small groups that they could take back to their regions. As we moved into small groups we were asked to focus only on the discussion topics selected for this years conference ( IE retaining old-timers and meds in recovery). We were also asked if our local fellowship thought these discussion topics were worthwhile. The consensus was that, although most regional fellowships seemed to like the topics the RDs got minimal feedback on them. I believe that may be due to a failure on the delegates part more than a collective indifference on the part of the fellowships we serve.

Feedback from small groups on retaining old-timers is listed below:

Tie them up, leave it alone because they are not working the steps if they are not coming to meetings, reach out to old-timers the same way we do newcomers, show them the respect they deserve, be patient with them, let them be human, stay in contact with them, police yourself and act like your in recovery, create an atmosphere of recovery at your meetings, don't put them on pedestals, etc.

Meds in recovery: the consensus was that although some of us need meds to deal with physical pain, or severe psychiatric illness, meds are currently being prescribed to several of our members by well meaning physicians who don't understand that moderate depression and anxiety are often part of the early recovery process and that by not allowing addicts to work through these emotional challenges by way of the 12 steps interrupts the recovery process and sometimes prevents us from progressing in our recovery. Often times addictive meds or meds of abuse are given to addicts, newcomers in particular, that actually contribute to relapse. Another problem found mostly in larger metropolitan areas are the use of harm reduction drugs such a methadone which serve only to keep the addicted whacked out on a legal drug vs. an illicit drug. We could continue this discussion ad infinitum with solving the problem. The consensus for a solution seemed to be educate physicians and judges on the recovery process and let them know what NA is all about. The second part of the solution is GOOD SPONSORSHIP. Tell your sponsees the truth and work with them on the steps. Like the saying goes "the truth will set you free but it may piss you off first."

The evening session started at 8:00 PM. Only motion 16 was introduced and it passed by near unanimous vote with only one abstention.

The following morning session brought votes on old business motions 6-14. All of these motions passed with amendments to a few of them (see attached motions lists). Later in the day we moved into small groups to discuss how to improve communication within the fellowship and increase interest in the CAR. Several solutions were offered to increase interest in the CAR:

shorten it up, keep it on a reading level that everyone can understand, use summaries at the end of motion discussions/recommendations, answer the question "what does this have to do with my home group?", remember the CAR is not for everyone, get it out sooner, etc. There was also discussion about other NAWS publication such as NAWS News, Quarterly reports, NAWS Annual Report, etc. The consensus was that these publications are worthwhile although they can sometimes be "boring and dry."

The evening session brought only a discussion and vote on motion 55 which failed by voice vote.

The following day was mostly discussion of World Service reports and literature distribution reports. I forgot to make copies of handouts by the presenters but will do so and mail them to the RCMs when I get home. There was an emphasis on the need to keep our group meeting lists current with WSO. This can now be done on our web-sites. I met with the keeper of this data for WSO and we checked to make sure they had a hyper link to our web site. The only problem we had is our web-site appears to be constructed with Microsoft programs and can't be read or located by some non-Microsoft browsers. Other than these discussions this Wed. session was brief and somewhat of a dud. Oh yeah motions 19-23 were introduced in the AM and all failed except motion 19 which was committed to the board.

The following morning election ballots were handed out, votes were cast, and ballots collected. We then went into discussion of projects for the WB. WSO has new computer software that will make task handling easier to track. This software will be in place in the near future. The budget for the next conference cycle was discussed. Motion 58 was introduced (see attached) and passed with only 2 votes against. Zonal reports were given and we adjourned for the day.

On Fri. the budget was discussed in detail voted on and approved for the next conference cycle. Several new motions were introduced and most failed (see attached). Some motions were never brought to the floor. That night there were 2 discussion groups. One concerning the use of the Internet for our fellowship and the other was RDs discussing Res. A. I went to the latter. I have given our PI chair all the info I had on the use of the Internet for discussion in the PI subcommittee. I am awaiting the results of the RD Res. A discussion and will get that out as soon as I receive it. It appears

some regions want to jump in and get Res. A Model 3 going and others want to let the river flow by itself without trying to push it. It is evident the complexion of the conference and communication throughout the fellowship continues to evolve. At this point I will mention that I was mistaken in assuming there would be an interim meeting in the off year of the WSC. Actually there will be 6 worldwide workshops. 2 to be held in North America and the rest to be held in other NA communities. This arrangement bears a striking resemblance to Model 3 of Res. A.

The day we had all been looking for finally arrived. Non-English speaking countries came to the mike to share what the conference means to them and their home fellowship. Several emphasized the need to act locally but think globally. We then went into a brief discussion about Res A. and the way we handle CAR results at the WSC. This was followed by a very controversial pseudo-survey of fellowship interest in potential changes to the Basic Text and Little White Book. Several of us were concerned with the way the questions were phrased which by their very nature produces very misleading results.

After the survey plaques were handed out to those leaving world services. The mike hog award was retired to the archives of WSO. We then closed the 25<sup>th</sup> WSC.

Again, I would like to thank all of you for allowing me to serve as your delegate. It has been a privilege and an honor to carry your voice to the WSC the past 4 years.

### Alt. RD WSC-1998 Report

Hello Family,

Well, as you all may have already realized there were some sweeping changes concerning world service structure at this years conference. As the saying goes, "The voice of the people is the voice of God." Our fellowship has spoken and has overwhelmingly approved the restructuring of World Services. The next couple of years should prove to be extremely interesting at the World level of service.

Speaking of restructuring World Services, elections were held to fill the new World Service Board, Human Resource Panel, and WSC Facilitators positions. Prior to the elections, I believe in an attempt to move through this process expeditiously and to make up lost time from previous debate over motion 1 and attempts to substitute for it, the voting delegates decided not to enter into a "What If" discussion. This proved to be a double edged sword because, although we made up time getting into and electing World Service Board members, not all the positions were filled. 18 of 24 open WSB seats were filled. This left the delegates with the problem of filling the remaining seats or leaving them open. After some very spirited conversation at the microphones, it was decided the WSB is an administrative board and that they should be able to function during the transition period over the next 1-2 years with 18 members. Had the conference simply followed Robert's Rules of Order I believe we may have had a full board. However, the decision was made to proceed to the election of the Human Resource Panel.

A motion was made and defeated to increase the number of HRP members to 6 instead of 4. Again, this board was not filled because only 3 of the 16 people running received the necessary 60% vote. The HRP was left with 3 elected members instead of 4. This time, after much discussion, the delegates decided to filling the vacant position by a single transfer voting system. I will not attempt to explain how that voting procedure works at this time. In short, this system did not work either and there remains 1 vacant HRP position. The same situation occurred with the election of the WSC Co-facilitator positions. There was only 1 of 2 positions filled.

Congratulations to all our new trusted servants. You may recognize some of the names on this list. Most of these individuals have served in various positions at the world level for several years. At this point I would encourage all interested individuals in our region to fill out resumes and get your names into the world human resource pool next year. I would also like to encourage our region to nominate Tim S. and Tony K., if they will accept, as prospective HRP and WSB members, respectively, to be placed on next years ballot. They both have the experience and clean time requirements for these positions.

Moving along, there was a great deal of discussion concerning developing regions funding (DF) and fellowship development funding (FD). These topics were presented by the transition group and many questions or areas of concern about what we as the NA Fellowship are of are not doing to aid developing regions and developing the world wide fellowship as a whole. This is a partial list of some of those topics:

Regions providing \$ to assist other regions in being able to attend the WSC.

Regions assisting other regions with literature purchases.

Funding Limits

Guidelines for DF funding.

Examining criteria to include US and Canada in attending WSC as some regions in North America do not have the financial resources to attend WSC.

Entire conference should focus on fellowship development issues.

Assistance to NA communities before DF funding.

Small group sessions to address specific needs with other conference participants.

Cooperate with Zonal Forums for FD activities.

Partial funding as opposed to complete funding for WSC attendance.

Continue FD trips.

Better communication to the fellowship as a whole regarding DF funding.

Education and training.

More translated service material.

More interaction with developing regions early in their development.

Regular meetings of delegates only every 2-3 years.

More effective vehicles to share our experience.

Same amount of time to review CAR by not releasing it until it is translated. (It is currently translated into 5 languages).

DF forum should be a fixed expense.

Funding for regions to attend local Zonal Forums.

Etc., etc.

There was no opposition to funding developing regions, including those in the US and Canada, and no opposition to having a line item in the unified budget for this purpose.

Speaking of Zonal Forums. The plains States Zonal Forum met on Thursday, 4-30-98, at 7 PM in the Warner Center Room. Several issues were discussed including defining the purpose of having a Plains States Zone and subsequent Zonal meetings. It was decided we needed to develop a statement of purpose which we did but I do not yet have a copy to share with you. Several of the other regions in our zone are interested in being a part of the zonal forum but would like to know what they are getting for their buck and how many bucks zonal attendance will cost them. Of course we do not have the answer to those questions yet except to say that moneys can be re-cooped when hosting forums. All regions in attendance realized the pluses in having the communication that zonals provide. We all realized our zone is still in its infancy as far as its development goes. We also believe the least amount of structure the better. We did find it necessary to elect a secretary/treasurer for the Plains Zonal Forum, congratulations Tim S. Regions in attendance were Neb, Best Little Region (TX), South Dakota, Iowa, OK Region, Mid-America, and Upper Rocky Mountain Region (WY). Manuel from Spain also attended our zonal meeting and provided us with some insight into the zonals they have in Europe. Brian from TX and Gilbert from Neb. Acted as our liaisons at the zonal group meeting on Sat. Gilbert will also act as our Internet liaison.

World is developing a new web site and will be conducting a beta test for this new web site starting the first part of July 98. To be part of that Beta test we have to contact WSO prior to May 30, 98. I have taken the liberty of providing this information to Don M. who has started an unofficial web page for our region. There is no guarantee that all who contact WSO for the Beta test will be included in the test. The new WSO E-Mail # is WWW.NA.ORG as of July 1, 1998. It was decided that our fellowship will continue to have a world Unity Day even with the 2 year conference cycle and 2 year world convention cycle. Packets have been provided to RCMs with this info in them.

Other business included a report by the translations group. The translation of the Basic Text into Swedish is nearly completed and should be out soon. The Translations group now has approximately 200 items, including IP's, that have been translated into 17 different languages. Man these people work hard. Some of the difficulties they have with translations is:  
Finding bilingual individuals who are in the fellowship that have a willingness to help.  
Finding people with knowledge of recovery and conceptual process fidelity.  
Resources both financial and human resources.  
Communication between each other and WSO and WSC Translations Group.

Translatable words such as addiction, bugaboo, etc.  
 Difficulty maintaining momentum from one trusted servant to the next.  
 Copyright issues vary from one country to the next.  
 Tracking and measuring results of their work.

The Translations group is doing a great job but need the spiritual, human, & financial help of the fellowship to insure their work continues to completion.

By the way, the cost of literature to Hazleton has been increased to where they are now being charged the same as our fellowship large purchasers. Hazleton remains the largest single purchaser of NA literature at approx. \$600,000 per year which is still a decline from previous years.

Of the new business motions (#86 to 126) only motions 98, 115, 119, and 120 passed. All other new motions failed, were ruled out of order, were withdrawn, or never came to the floor for debate.

Last but not least, I would like to thank Tim S. and Tony K. for helping me the past 2 years. Your guidance has been deeply appreciated. Most of all, Mid-America Region, thank you for providing me with this opportunity to serve you. You are, of course, the greatest region in the world. In the coming months I will review my notes from WSC as well as the literature I brought back to see if and what I may have missed in this report and will include it in the August report. One thing I did forget to mention previously is that although the WSC Policy Committee is no longer a standing committee there is an interest by some other regions, including other countries, who would be interested in sharing copies of policies with us as well as receiving copies of our RSC policies.

**Letter from a concerned member:**

I would like to address this service body regarding the controversy concerning the monies given to our RD and RD2 to attend the World Service Conference.

I attended the May, 1999 RSC at which our then RD2 asked for guidance from this service committee on concerns and problems she felt she experienced at the WSC she had just attended. Although I felt she was asking for a concrete solution from this service body, what she received was the following suggestions:

1. She could hope for the best and could again try and share a room with our then RD.
2. She could register with the WSC to share a room with another woman. It was my understanding with this suggestion that we would foot half the bill of this room.
3. She could get a room of her own, but she would be responsible for the other half of the expense of this room.

Never, at any time during this discussion, was our RD2 offered extra monies to attend WSC.

Our Rd2 was unable to attend the Sunday meeting of the February RSC, however, she did make arrangements to let this service body know that she had taken one of their suggestions and needed her half of the money that was budgeted for the WSC.

There was, to put it mildly, an immediate uproar. The concensus of this uproar seemed to be how unfair the very same suggestions given to our RD2, would be to our RD. The controversy was ended when an extra \$1000. Above the budgeted amount was given to our RD and RD2.

This leads me to address some very grave concerns I have with this service body. Although I do not presently hold a position at region, I have attended all but 2 RSC's in the past 2 ½ years and feel that I am a part of this service body, and as such I really feel that we need to take a serious look at the messages we are sending to our region as a whole, but more so to our female service workers.

These are my concerns:

This was treated as an emergency – immediately money OVER BUDGET was thrown at the problem. In truth, the problem was brought to this service bodies attention a full 9 months before February RSC. If we had addressed the problem in May, the groups could have had a say in whether to go over budget. This would have been in keeping with the concepts.

Since this was treated as an emergency, I am left with the feeling that our RD2 was not taken seriously at the May RSC. This can be for only 2 reasons:

- A) Our RD2 did not have as strong of personality as some on this service body. I assure you however, that the principles of this program were followed by our RD2. She could not have had to yell and scream to be taken seriously.
- B) She was not taken seriously by this service body because she was female. This is of course, in direct conflict with the principles of our program.

I find the message I received from this service body very disturbing, for the following reasons:

1. She simply was not taken seriously in May.
2. The exact same suggestions were given to our RD, which happened to be a male, as was given to our RD2, which happened to be a female. The uproar was because these suggestions were deemed unfair to our RD. Why were the same suggestions fair for our RD2, but not for our RD. Could it have been because our RD2 was a female?
3. Why was extra money not suggested in May when our female RD2 brought up the problem, but was immediately suggested and passed to go over budget in February when our male RD would have to follow the same suggestions as our RD2. This was passed even after our RD refused it because it went against the group conscious of our region.

As to single point of accountability, we must look at ourselves. We cannot blame Betty as she followed the principles of this program when she brought the problem to our attention, and again when she took our suggestions.

We cannot use Carl as a scapegoat. He followed Robert rules of order, raised his hand and waited to state his opinion until after I spoke up, which was ten minutes into the "That's not fair" statements. While some sat silent,

There were 35 people that signed in for attendance at the 1<sup>st</sup> Mid-America Regional Service Assembly. The majority of the people were in attendance for the day Saturday. After supper Saturday night we lost a few bodies, these were mainly local people that did not plan to spend the evenings.

During the Marathon Meeting (I mean Jeannie and Bernie's workshop) we had the ice cream social. After the workshop most participants were shot. Approximately 12-14 people spend the night at the Assembly.

During the Sunday Open Forum the following comments were heard:

- Was great, need to have more of them? One time a year for an Assembly.
- More Communication to the groups and fellowship about the assembly to get more attendance.
- Con, to the facility was not being able to cook in the Main Building.
- Expected more people to show.
- Focus of Groups to Area to Region, that where the struggle is.

The following evaluation was presented to each participant to complete prior to them leaving the Assembly. There were 20 returned Evaluation and the percentages of respondents are listed below the numbers.

# TAX OPTIONS GROUP BULLETIN

## *Taxes and NA in the USA*

In both the January and March 1993 issues of the *Conference Report*, the Tax Options Group promised the fellowship a report of the information gathered during its existence, specifically anything that might be helpful to elements of the NA Fellowship in the United States of America in making decisions about how to conduct their tax-related activities. There have also been several requests to answer a few specific, commonly asked questions about taxes. We believe this document performs both these functions. It was compiled on behalf of the Tax Options Group and hopefully contains information that is relevant to NA groups, service corporations, and local service committees in the United States as they consider how best to meet their obligations under USA state and federal tax codes.

### *Introduction*

One of the marks of recovery is an ability to accept responsibility. As individuals, recovery gives us the wherewithal to start fulfilling our responsibilities as family members, neighbors, coworkers, and citizens. The same applies to our collective behavior as NA groups, committees, and service corporations. As collective citizens, our groups, service boards, and committees are obliged to obey state and federal tax laws like everyone else. The question is, what are those laws and how do they apply to us?

### *The meaning of "nonprofit" and its relation to tax exemption*

Since our first NA meeting, most of us have heard NA defined as a nonprofit fellowship or society of men and women for whom drugs had become a major problem." From that, an awful lot of us have jumped to the assumption that not only were NA groups, service boards, and committees exempt from taxes and tax laws but that contributions to NA at any level were tax deductible. Unfortunately for us, neither of these assumptions is warranted.

Very, very few NA groups gross substantially over \$5,000 a year. However, if your group or committee does gross over \$5,000 annually, it may still be simpler and less expensive just to pay income taxes than go through the process of filing for tax exemption, incorporating (which usually goes along with the process of filing for tax exemption), and keeping up the records and reports required to maintain tax-exempt status once it's granted. If you believe your group or committee would be better off simply paying income taxes and being done with it, talk with a local tax consultant.

It's true that certified nonprofit organizations are "generally exempt from state and federal taxes and that contributions to such organizations are often tax deductible. However, according to the tax people, it's not enough to operate in such a way that a group or committee uses whatever contributions or other income it receives solely to fulfill a charitable purpose. To be certified as a nonprofit organization, an NA group or committee must file official requests with both the state and federal governments for tax exempt status. Until such a request is granted, an NA group, service board, or committee is not considered to be "nonprofit" by the government. Instead, it is treated for tax purposes as a taxable organization and is subject to the same income tax regulations other such organizations must abide by.

This leaves the NA group, service board, or committee with two alternatives: abide by regulations for taxable organizations, or file for tax exemption. Both alternatives have their benefits and their drawbacks.

### *Alternative 1: abide by regulations for taxable organizations*

For many NA groups and for some NA service committees this alternative actually makes more sense than one might think at first glance. This is because US federal tax regulations and most state regulations do not require organizations with gross incomes under \$5,000 even to file tax returns, much less to pay income taxes. If your group or committee receives, as an average over a three year period, less than \$416.67 a month in total contributions and income from sales of NA literature, event tickets, T shirts, or other items, you're in the clear. (This means \$416 a month before expenses are taken out, not after!)

If this applies to your group or committee, all you need to do is make sure your treasurer maintains complete, accurate records of your group or committee's financial activities. The guidelines and record sheets your treasurer will need can be found in the Treasurer's Handbook, available from the World Service Office. So long as you maintain such records, you will be able to justify not having filed tax returns should state or federal authorities ever ask your treasurer about the matter.

### *Alternative 2: file for tax exemption*

If your service committee has a gross income substantially in excess of \$5,000 a year, it should probably incorporate and file for state and federal tax exemption. Incorporation will provide your service committee with the stability it needs in its legal identity to maintain tax exemption over the years, regardless of who the committee's officers are from one year to the next. Filing and maintaining tax exemption is a complicated process. Doing it incorrectly can bring about grave legal and fiscal consequences for your service board or committee.

For this reason, we encourage you to consult with competent local legal and tax professionals who are familiar with the needs of small nonprofit organizations when preparing your corporation papers, filing for tax exemption, and maintaining your nonprofit tax reports.

This alternative may also apply to exceptionally large groups which host many meetings each week. In addition to having gross incomes substantially in excess of \$5,000 a year, such groups sometimes lease or purchase buildings for their meetings and activities and take out their own liability insurance policies. Such groups will want to incorporate their steering committees and file for tax exemption. These super-large groups, however, are quite rare. Most NA groups will be served best by simply maintaining good financial records and, in the few cases where it is necessary, paying the minimal income taxes they owe the state and federal governments each year.

If your group or committee has determined that it needs to file for tax exemption but is hesitant to incorporate, it can operate as an unincorporated association of individuals. Unincorporated

associations can apply for nonprofit tax exempt status, just like nonprofit corporations, without being bound by the corporate structure. However, be aware that incorporation can provide the group or committee with long-term stability that not only makes it easier to maintain tax-exempt status but actually helps ensure that our primary purpose continues to be fulfilled, year after year. Your local tax consultant can provide you with specific information on the pros and cons of operating as an unincorporated nonprofit association in your state.

Can members deduct their contributions to an NA group, service corporation, or committee from their tax bills?

No, not unless the group has been granted tax exempt status by the state and federal governments. If you deduct your contributions to a group which has not been given tax exemption and are later audited by tax authorities, you may find yourself in serious trouble.

Can't we get government tax agencies to grant a joint exemption for all NA groups, service corporations, and committees in the USA?

In 1992, the Tax Options Group was set up by the World Service Conference to investigate this idea with assistance from an experienced tax attorney. The group found that, to be granted a blanket exemption for NA, we would have to establish a system of controls over the finances of all American NA groups, service boards, and committees that would ensure the use of all income solely for NA purposes and require regular, reliable reports to some central NA organization which would account to tax authorities for the activities of Narcotics Anonymous. In practical terms, such a system would be nearly impossible to manage. In spiritual terms, it would run directly against our tradition of group autonomy and our concept of service, not government, within our service structure. For these reasons, we are simply recommending that each individual NA group, service board, and committee in the United States take up its responsibility to abide by all applicable tax regulations, maintaining accurate financial records and either paying whatever state and federal taxes, if any, are due or filing official requests for exemption from taxation.
