## ARTICLE II

The primary purpose of MARSCNA is to carry the message of recovery to the addict who still suffers and to further the unity of the fellowship within our region and other regions by maintaining communication between the areas represented and Narcotics Anonymous as a whole, in accordance with our Twelve Traditions.

It was a long meeting with emotions running hand in hand with the tension. All areas were present except for Central, who sent a written report. All sub-committees were present save Outreach.

In old business it was stated that the newsletter audit was completed and there was further investigation needed. Clay W. was elected Co-Chair and Melissa will be Treasurer for another term. Nancy A. will serve another term as P.I. Chair. The following positions are open at the regional level: P.O. Box Chair, Activities Chair and Camp Out Chair.

The order of business was changed in motion #4 in new business to elect Samuel L. as newsletter Editor, who will follow up on motion #3 to change the format and mailing of the M.A.N..

After much discussion, the region then voted on a motion to take back to the groups; An amendment to Article XIII to provide the area that might be affected with adequate time to resolve it's problems before the loss of its voting privileges. I urge all members to take an active part in this vote.

There were then several motions on the agenda from Steering. They ranged from the handling of funds, to updating and editing the guidelines with an additional clarification on abstention votes, to having the next convention at Hutchinson, Ks. in 1999. All were passed with the exception of locking us into a five year contract, which went back to the Steering Committee.

Tim S. spoke about having the next Zonal Forum in Feb. 1998 in our region. A vote of confidence regarding this matter was given to the R.D. and Activities sub-committee.

Mark H. read 5th Tradition A.S.C. minutes and expressed some concern about accusations made of Wichita Metro Area concerning missing funds. This concern was based on events that have taken place in the past in the 5th Trad. area. There was a rebuttal from Anita J., representing that area.

It was then that the M.A.R.S.C., in the interest of unity, recognize Article XIII. Fellowship For Freedom was moved to abstain from this vote. The 5th Trad. R.C.M. chose to leave at this time. A committee was formed to go to the next A.S.C. of the 5th Trad. to help the area resolve its problems. It should be stated that this action was taken in the spirit of healing and helping and should not be misconstrued in any way. The M.A.N. is sincerely hopeful for the active participation of the 5th Tradition area in the future.

SICKNESS

Once we stopped using drugs, many of us started comparing ourselves My stomach churns like to other addicts. We focused on our a storm, differences rather than our similari-Seeing only the differences made it easy to think that maybe we didn't belong in NA.

Denial is a prominent aspect of A nightmare of the disease of addiction. Denial keeps me want to scream. us from seeing the whole truth about Every time that I eat, it just won't ourselves and our disease. Feeling astay down, we addicts is a manifestation of this denial. It helps to take an honest look at the unmanageability of our lives that resulted from our drug use. We look especially at our relationships, our employment, our living conditions, and our financial obligations. Instead of thinking about the good times we had using drugs, we try to remember when we may have said, "What am I doing here? Why do I feel this way? How long has it been since drugs worked the way I wanted them to?"

Eventually, we all face a basic question: "Do I want to stop using drugs?" Many of us could not answer this question immediately. However, when we willingly and honestly looked at our past, we found many reasons to stop using drugs. Your answer to this question can set the course for your future recovery.

The disease of addiction is progressive. Our experience during active addiction proved that to us. Continued drug use destroys us in body, mind, and spirit. We believe that, for addicts, continued use of drugs leads jails, institutions, or death. Breaking through denial gives us a clear picture of the destruction in our lives. With this in mind, we can look for solutions to our problems.


"Jack!" He yelled, giving his old friend a big hug. "How ya doin'?


Is there NA in heaven?"
