MEETING ETIQUETTE

From The New Life Messenger, the Ottawa, Ontario, area newsletter

Danger! Reading this might help you enjoy your meetings and improve your ability to carry the message to the still-suffering addict. Narcotics Anonymous offers us many tools to use in our recovery; most important are the steps and traditions. However, the "glue" that holds our fellowship together is the NA meeting, the place we gather to share and learn and grow. Our meetings should offer fellowship, a safe haven for addicts, and a sense of welcome to the newcomer. Ultimately, every meeting's first priority should be recovery. Everything else is secondary. The "we" of NA is made up of a whole bunch of "you's" and "me's." Our behavior can make or break a meeting. With this in mind, I offer this "thumbnail inventory" of meeting etiquette. Ask yourself these questions for a look at your own meeting behavior. Maybe there's something you can change to make NA a better place.

- 1.) Do you respect the meeting enough to get there on time and stay in your seat until the end?
- 2.) Do you interrupt the meeting with chatter?
- 3.) (Smokers only) Is having a cigarette break so important that you interrupt the meeting to have it? Do you ever miss part of the meeting because of it?
- 4.) Do you listen to the readings, or do you "tune out," maybe even start talking?
- 5.) Do you listen to the NA announcements? If you've heard the same one ten times, do you thinkthat means everyone has?

- 6.) Do you ever walk into a discussion group late, share, and then leave? Do you give others the same attention and respect that you believe you deserve?
- 7.) When the collection for the Seventh Tradition begins, is this an important part of the meeting for you or a cue to start talking you your friends? Picture this: A newcomer hears the chairperson say, "We have no dues or fees...." but misses the rest because the room breaks into conversation. Meanwhile, he/she sees people putting money in a basket and passing it around the room. What would you think?
- 8.) Do you shout out your own additions to the steps or traditions readings?
- 9.) Is your meeting facility as clean after the meeting as it was before? If not, why not?
- 10.) What are you doing to make the meetings you attend better than they would be without you?

Just like recovery itself, being complacent about our meetings can be a very dangerous thing. It has been sad to see meetings close over the years in this area for no other reason than lack of meeting etiquette. It is our duty to provide the best meetings we can, both for ourselves and for the addict who will be arriving later today, tomorrow, or the next day.

Remember our Fifth Tradition! BK

YOUR STORIES AND POEMS

I Am an Addict. My Name is Sherrie.

"I'll kill those **** dogs!" That is the command that six drug enforcement agents screamed at me as they surrounded me. It was a cool day of September 26, 1996 when my children, significant other, and I were packing the car to leave the state of Kansas. As we were walking to the car, trying to pack only what we needed, six drug enforcement agents ran up on us in all directions. They surrounded us into a circle, leaving us with no where to run. As our dogs were barking at he cops, my babies were crying, and we were frantic. The cops walked closer to us with their guns cocked sideways at our dogs. I put my hands in the air and walked towards the cops to turn myself in.

I can remember all those feelings. I feel as if it happened yesterday. The shame, anger, hurt, scared, tired, but most of all I felt relief. No more worrying about getting caught, no more paranoia that everyone was a cop, no more lying, cheating and stealing, and no more chasing the high that I had grown to love so much.

The arrest was very embarrassing. I will never forget how they circled me, put me down on my knees, my hands behind my back, handcuffed me, and stood me up. As they were walking me towards the police car, the cops read me the charges, then my rights. My two boys, ages two and four, at the time were in complete strangers hands and put in a separate vehicle. I can still see their faces. I can still see the tears run down their scared little faces. I can still see their arms stretching out to me yelling mommy. As they drove me to the police station I wondered if I'd ever see my little boys again.

It was a real rat race inside the police department. The detectives were walking around patting each other on their backs and congratulating each other. I hated them. I was real rebellious. I had been up for about seven days straight and was in no mood to deal with the procedure, pictures, and fingerprints.

Dressing out was not an easy task for them. I just wanted to be left alone. I wanted to eat and sleep, but they had other ideas in mind. Three detectives put me in a little room to question me. They said "Sherrie, you have one chance, and one chance only to ever see your kids again." They tried to trick me, and the thing that came to my mind was what my brother Randy said, "Sis, don't ever tell on anyone." So I basically told on myself. What I said in that room could have put me in prison for 154 months, because

of previous possession of cocaine charges in 1989.

I sat up in jail for quite some time. My charges were manufacturing methamphetamines, possession of methamphetamines, possession with the intent to sell, no tax stamp, and endangerment of my children. I could handle the drug charges but the charges that hurt me the most were the endangerment of my children. I was so embarrassed to place my children in the dangerous situations that they were in. Needless to say my bond was so high, \$25,000 cash. I sat in jail. I didn't know anybody with that kind of money. The jail was overcrowded, ten people in a five man cell. I had been there awhile so I didn't have to sleep on the floor. There was no ventilation, therefore the stench and stagnation was terrible. I dreaded the girls that came in on a DWI in the middle of the night because in the morning the cell would reek of alcohol. I was physically sick in jail, de-toxing from drugs with only the help of other women who had previously been in my shoes.

After about 55 days in jail my court appointed lawyer got the judge to dismiss the charges because the state kept putting off my preliminary hearing. The drug labs in Topeka were so backed up that they couldn't get the results back in ample time to satisfy the courts, so they let me go. I found out while I was in jail I had no friends and family. In addition, my significant other of six years had walked out on me too. The day we went to jail was pretty much the last time we spoke. He had the same charges as I did, and his lawyer told him to save his ass, and that is pretty much what he did. I cried every day for a year. I didn't understand why we couldn't get clean together and raise our children together. But as time went by, I realized our relationship was based on drugs, lying, cheating, and stealing, and there is no way to salvage it.

When I got out of jail I had no where to go, no home, no children, no clothes, no money. I walked down the street with shorts on, a summer shirt, no shoes, on a ravaging cold November day. I was cold, angry, hurt, lost, and abandoned. I walked to the NA meeting, I opened the door, walked in, sat down, and talked to group of people I didn't even know. They were understanding and friendly. I felt a warm sensation throughout my whole body as I opened my heart to them. All my fears were lifted, they told me everything was going to be all right, they would help me, but first I had to help myself.

I went to treatment. At treatment I met other individuals just like me, their stories are a little different, but we all share

the same pain and guilt. We all suffer from the disease of addiction. There I learned that I was not unique, and there I found out there was hope for me. I am very active in my recovery. I am now a "part of". I have a new family, one that likes me for me.

There is life after drugs. November 14, 1999 will be three years since I took my last drink, inhaled, injected, digested any illegal drugs into my body. I put my recovery as the first priority in my life, because I know if I pick up my life would fall apart. Today I live life on life's terms, I practice the twelve step program in all my affairs. I have a real job, it doesn't pay much, but it is legal. I am a good mom. I help newcomers who walk in the door scared like I was with their recovery. I give them hope and love. I listen to their fears and offer them advice on what worked for me. I am an addict. My name is Sherrie. I suffer from a disease which there is no know cure, it can however be arrested at some point and recovery is then possible.

CELEBRATION OF RECOVERY

I have been involved with NA service for the majority of my recovery, and have found it very fulfilling and a necessary part of my program. The put three years I have been a member of this regions convention committee and this has been the most fulfilling of all. There is no way to put into words the experience and knowledge I have gained from helping organize and create such an event. I have learned patience and tolerance, unconditional love and spiritual principles that have helped guide me in my daily life I have built many cherished friendships through the years, many of which came from being part of the convention committee The wisdom mid open mindedness I have today is owed to this, and to the people who helped teach me these valuable lessons. I can't compare any other experience to it. Working with ten or more individuals, each with their own beliefs and opinions, some of which I don't always agree with, is quite a task. Personalities may flare or clash from time to time, but the end result is a gift. The spiritual rewards are astronomical and irreplaceable. After all, a convention is a celebration of recovery, and what better way to celebrate than with the people you love and care about. I am chair for the 2000 convention in Great Bend and am anxious for the time to get here. I have been through some personal struggles to get here, but every bit of it was worth it. The things I have learned and the growth I have accomplished are priceless achievement. I'm not in this for ego or assurance. I'm in this for all the unconditional love I give and receive and the passion and devotion I have for Narcotics Anonymous. Today I am truly grateful.

➤ 1.) RD and Alt. should continue on a two year rotation and the Region send the delegates to the WSC Interim meeting on the off year of the World Service Conference.

Financial Impact: Should save us money as the interim meeting will be shorter in time than the conference.

*Note: There was much confusion concerning whether the was a motion or a recommendation. Some Areas didn't even take it back to their groups. As a result, Billy asked that this be taken back as a motion.

➤ Motion: Carl K. moved that this <u>recommendation</u> be taken back to the Groups in the form of a motion.

Second: Too Tall

Passed - take this back to your Groups.

➤ Outreach subcommittee is requesting the RCM's obtain information from their Groups and Areas. Do they want to have the RSC rotate, in an alphabetical order, between the Areas? Do they have an interest? Do they have the facilities and the manpower to do so? If so, how would they like to see it done (logistics)? Etc.

Currently we are renting the 4H building in McPherson for \$200.00 for the weekend. In addition, we are giving the activities committee \$200.00 for seed money. Usually the RSC pays for itself with the dance, raffle and auction.

It is felt by the Outreach committee that rotating the RSC would promote unity in the Region and give the local Area's people a chance to get involved.
