Pegional News

February Regional

This regional started off with all areas represented by RCM's except for Central. There was an open request by Shelly W. for areas to monitor the distribution of their regional meeting lists, and if they consistently had a surplus, to please report it to the PI committee in the hopes that we may cut some printing costs. Nancy A. will is no longer able to continue as Co-chair of the region at this time, and the order of business was changed to elect a new one. Billy C. is now our new RSC Co-chair! The MAN congratulates him!

The treasurer's report was given and there was discussion about expenditures. RCM reports were then given (more about that in Around the Region on page three), and then the sub-committee reports. In addition to the Regional Delegate and his Alternate giving their reports, there were reports about the Service Assembly in Oklahoma, and a detailed report on the Plains States Zonal Forum.

The remainder of old business consisted of financial liabilities owed to the region, insurance, the regional logo, next years convention, and of course, the optimal budget. After crunching some figures, it was agreed that Doris B. still owes the region \$91.00 and we will continue to take the appropriate steps to deal with this. There are still some bad checks to collect on, but the region has decided to write one amount off and pursue the others in small claims court.

There were some results from the detective work on the pricing of insurance, and it seems policy per policy, the region has about an average deal. We will continue to seek cheaper coverage. It also seems that when Samuel L. designed the logo using the NA logo provided by the WSO, it carried with it copyright protection, so the regional logo is covered like a blanket! Thanks, IIP. Conventions in the future will rotate between Great Bend, and Hutchinson, Kansas and the next one will be held on April 14th-16th, in the year 2000. The optimal budget was accepted as written!

In new business, Lois W. was elected Chair of the Activities Sub-committee and Dave R. was elected the same position for H&I. The region will donate \$100.00 seed money for the Zonal and it was decided that the secretary would begin to keep a running documented record of motions passed. A motion was then defeated about restructuring the steering committee. Heavy discussion ensued about a motion to send \$1951.05 to the WSO as a donation, but in the end this one passed. We then passed a motion to form an ad-hoc committee to examine the region's accounting process, as well as a motion that locates the Zonal Forum in McPherson twice a year. The RSC wrapped up at 5:35 p.m.

Sub-committee Reports

Activities: Lois W. is the new Chair for this committee and they have Betty P. scheduled to speak at the next RSC. The theme for Soul to Soul will be: "Share Your Soul at Soul to Soul Spiritual Retreat."

Campout: They report good communication in the committee, with lots of fundraiser's in the future.

Convention: Jon Mc. was nominated as Chair for MARCNA XVII in 2000 and they have yet to vote on a location for the next convention.

H&I: This committee has a pamphlet project in the works that will include a regional meeting list. Also sponsoring by mail. Two learning days are scheduled. Dave R. was nominated as Chair.

Literature: The literature committee is having troubles with finding solid commitment and involvement, though four areas were present for the meeting. An inventory of regional literature is in the works.

Newsletter: The editor whined once again about someone "assuming the position." He also gave a financial reporting from the last issue.

Outreach: Addicts on Asphalt and more is in store with this committee. They are currently considering guidelines.

P.I.: They report six areas in attendance at this sub-committee, with workshops and learning days planned. They are talking about accurate distribution to each area, based on the number of lists given out.

P.O. Box: The box fee is due, John reports not much else. Steering: They started off about insurance, discussed the logo and its usage, and the new guideline booklets. There was also discussion of Oklahoma's first Service Assembly at the late night meeting, as well as the two new positions opening up on the committee in May. Thanks, Tim S.

The regional service committee is a resource pool, gathering service information and experience to guide and strengthen the areas it serves. To do this, each regional committee organizes itself and performs its duties differently, according to the needs of its member-areas.

World Update

C.A.R. 1999

Once again, the Conference Agenda Report is out for review and your vote. Take this time to attend a workshop either with your home group or area service committee and find out just what the C.A.R. is all about. This year there are only 12 motions, which is about 1/3 of the usual size. For those that keep up with world services knows that in the last few years they have changed to a more "discussion oriented" structure over the past "motion madness" structure. That's not to say that a large number of motions and amendments won't be introduced in the new business portion of W.S.C., but it's most likely to follow the path of the re-structuring we all have laid out for them. Regional Delegate and Alt. Delegate

Carl K. (R.D.) and Betty P. (alt.R.D.) both attended the Plains State's Zonal Forum in Lincoln NE. held Feb. 13th and 14th. Along with them were 8 other members from this region which means we were represented pretty well. The C.A.R. was the main topic but time was allotted for others set out by both last year's conference and past zonal meetings. Topics included Fellowship Communication, Insurance, Fund Flow, and G.S.R. Assemblies. Six regions make up the zonal forum and all were represented through 35 members. Two members of the World Board (Cary S. and Craig R.) were there to answer questions and explain some of the reasoning behind their recommendations on the 12 motions mentioned above. The theme that was unofficially set was "Think Globally - Act Locally" and Betty presented some food for thought by saying "If every registered group gave just \$20.00 a year W.S.O. would be OK" - there are 90,000 registered groups in the world.

Some members are under the impression that, at the last minute, they can change their mind about what they purchased in preregistration, and get their money back. Ask Grateful Gus!

This issue's question comes from a member of Waterman Street NA in the Wichita Metro Area:

"What's the difference between a 'group conscious' meeting, and a 'business' meeting?

Our Fourth Tradition states: "Each group should be autonomous, except in matters affecting other groups or NA as a whole." Considering this, the difference between these two meetings is entirely up to the group, as long as it doesn't affect other groups or Narcotics Anonymous in general. Typically, a group will hold a "business" meeting once a month to take care of, well, business. Buying suppies, paying rent, scheduling meeting leaders, and the like. Any of the regular business that it takes to keep a group running and carrying the message effectively.


These meetings can also be a forum for addicts to express their dissatisfaction with policies or procedures that the group has adopted. Remember, the member has the most power to change things in the group structure.

If these issues are important enough to upset a majority of the group, a "group conscience" meeting may be called at an announced time to address a specific issue where the votes of the entire (or at least a majority) of a groups' members are needed to get the "conscience" or desire, of the group. Generally, regular members are not found at a business meeting, although they are always welcome.

The steering committee (the elected officers and trusted servants of your group) is all that is necessary to make decisions about paying the bills, etc. although many sponsors encourage their sponsorees to attend business meetings, especially if the member has shown an interest in getting involved. This guarantees a good rotation of the trusted servants in the group.

This is by no means the only way that a group can be structured. It is just a common practice among many groups in the world. The Fourth Tradition allows each group to structure itself in the way that it sees fit, according to its' membership's "conscience." As long as it is reliable, consistent, and effective in carrying the message to the addict that still suffers, a group can arrange and format itself in any manner it chooses.

The Results of the MAN Survey at MARCNA XVI

The editor of the MAN handed out and displayed 100 surveys at the convention to try to find out how addicts felt about it, and what changes that they would like to see. Of the 100 surveys, only 22 were returned. While this might not be representative of our fellowship as a whole in this region. It is certainly representative of the members who cared enough to provide us with their input. Here are the results, question by question:

- 1. Are you satisfied with the cost of registration? 17-Yes, 4-No, and 1 left blank.
- 2. Are you satisfied with the activities provided? 15-Yes, 5-No, 1-Somewhat, and 1 left blank.
- 3. What are some of the activities that you would like to see at future conventions? They are as follows: 2 people said organized activities for children, 2 wanted a jazz or blues breakfast, also listed were: bike games, best hat contest, comedy shows, ice cream social, and an unconditional love circle. Λ full 12 surveys left this question blank.
- 4. How should the location of the convention be decided. 5-Let RSC decide, 19-Centrally located, 3-no answer.
- 5. Should the convention offer lodging or should individuals be responsible for their own. 11-Stay the way it is, 7-Be responsible for your own lodging, 4-no answer.
- 6. Overall opinion? 20-Good to very good, 2-no answer.
- 7. Suggestions/complaints? 9-Have family orientated activities, 2-Keep the pool open all night, 1-Make the cost cheaper, and 2-no answer.

Healing

Today I am celebrating 18 months clean time and I'm really juggling a lot around in my head. Some of you know how it feels to lose a friend to the disease...I lost the best babysitter my kid ever had Tuesday. They loved each other and I loved him too. He would have been 25 the day after his death. I have been praying...for me to make the right choices...for his family and their pain...and for any addict that could be next. Karl died of an overdose.

I met him when he was clean, then I watched it happen. (Powerless!) First it was just a beer, then pot and pills and on and on...I hate it, but I'm just as powerless over someone else's disease as I am my own. I get pissed at the disease of addiction. I have many teenaged friends, some clean and some not. I see several of them who can't manage to stay clean. I just want to shake them and yell, "YOU ARE GOING TO DIE!"

I know that won't work. If it did, I would have gotten clean years before I did, but being powerless still sucks. I believe the basic text what it says on page 84 about our choices: jails, institutions, and death...or recovery. I've lost so many people to addiction and I know all of you have too. Drunk driving, suicides, overdoses, murders, shootouts, and thousands of other ways those addicts endanger their lives every day they continue to practice. Karl was not just another statistic, he was too close to home.

I've been told that 15 of us die for every one of us that makes it. I look around and wonder who will be next. I hate feeling this pain, but I know that if I keep my faith in HP, I won't have to use over it. I am truly grateful that I have escaped the insanity "just for today." I look at his picture, and I'm hurt and angry at the same time. I just don't understand, he had the same choices. Why was it so different for him than it is for me?

Please pray for my family and I. Please pray for Karl and his family. Pray for the addicts who are still living with the insanity of this disease, and pray that all of us make the right choices. It could have been me...lt could have been you...But for the Grace of God! I love you all. Thank you for letting me share my pain and helping me to let go.

During the last several months I have watched as others have been on the "roller coaster" ride of life, and I have been there to be of support and strength—not realizing that I would need that type of support and strength to walk through situations that have come my way.

As I look around, I realize that my relationship with my HP is the strength of my soul. This is the life line that I will use to pull myself beyond the depths of despair and bring myself back up to the world of living that I desire and have been a part of for so long.

Dealing with life situations is not always easy but it is necessary in order to function—in other words, if I run and hide, what will I gain? I remember when I first got clean how easy it was to hide from "feeling" or "dealing" with any type of situation. The tools we had when we got here were pretty rusty and in very bad shape. It took years of work to sharpen those tools so that when used as they were supposed to be, the "work" was not as hard and laborious.

I was listening to a gentleman the other day talk about Sponsors and how important they were in his life. I totally agreed with his philosophy and was very inspired by his open honesty on this subject. Without a good sponsor in our lives to help us through the good times and the bad; to listen to our gripes, complaints, laughter and bullshit; and to be a good friend-----how could we expect to survive "life" without going back to using? Sponsors teach us so much on the relationships we need to develop with others in and out of the world of NA.

Today I am forever grateful to be able to "see" the errs of my ways, and to take this time to make them better and to change ME where I need to. My HP, my sponsor, my family of NA, and my loved ones are so very important to me!!!!! You keep me alive so that I can live and enjoy my life as a person of freedom.

One Addict's Journey

(The continuing journals of "M.")

October 16th, 1995:

It has come to my attention that I don't that even if I don't seem to feel fulfilled, it's great to be on the outside looking in! I never thought that I'd be glad to just feel the warmth of the sun's rays on my face. I took in things that I usually take for granted all morning long, but my wife's lips, man they never tasted so good.

I was disappointed that I couldn't find a place at nine in the morning that sold a decent ribeye, but other than that, there was nothing that could ruin my day. The woman copped an attitude about me taking off on the bike for three and a half-hours. I swear, sometimes I don't know what's going through that woman's mind. I know that I've done a lot to hurt her and cause her to distrust me, but I just wish that she could turn loose of me for awhile. After all, I did just get out of jail.

I went to treatment tonight and we worked on priority lists. I got quite a bit out of it and got more in touch with where my program is, and ought to be. I need to start putting it first in my life. It's tough, because I've always felt that I should put my kids above everything. But, if I don't stay clean, there won't be any kids to worry about...

My counselor is moving to another center in two days and I'm kind of pissed about it. I feel like I've been robbed of my relationship with her. If anyone else had done my intake interview, I'm not sure that I would have come back for treatment. I really felt like she cared about me and the outcome of my treatment. I hope that I can get the same sort of feelings and trust for the person who replaces her.

I went to a meeting tonight and shared about my experience in jail. I thought I must have sounded like an idiot until this dude came up to me after the meeting and told me that I really helped him. Imagine! Me, helping anyone! He said that he was facing some jail time that was to begin tomorrow morning and up until he had listened to me share, he had been pretty nervous about it.

I went home tonight feeling like I had just blown a doob'. I can't remember feeling this good without some sort of chemical inside me. As I said my prayers to my creator that night, I began to get some hope that maybe that aura of "good feeling" that I see on everyone at NA could really happen to me. I was pretty sure I was on a pink cloud. I remember thinking that in between thanking God for having such a great day.

Teaching?

When I came into Narcotics Anonymous I added "teach" to everything. I was taught to work the steps and use the tools of recovery in treatment, I was taught to hug and be hugged also in treatment. At my homegroup I was taught to share on the given topic, get use a sponsor, give money to the basket and why we do so, and introduced to service work. I also was taught that the "doling in the basket isn't enough in today's society and what I have in this developed country is taken for granted.

All this time I have been on the other side to, I am responsible for teaching what was so freely taught to me, unfortunately I don't see the same teachings happening. I attend meetings where members are celebrating 1 or more years and yet to have done a 4th step, let alone grasp the freedom from doing one. I see members balk at putting money in the basket but frivolously spend it immediately after a meeting. I see members hang on to "newcomer" status for years, just so they can receive the sympathy and attention so freely given in meetings! Members in the past few years have been taught that "no addict is turned away" at all functions so being responsible and paying your way isn't honored as much.

If you took the time to read this, ask yourself "what was I taught and what am I teaching now?" Hopefully they will be similar.
