Following this logic I am going to make a motion (under new business) That this conference advance the MARSC Treasure \$250.00. These funds will be used to:

- 1. investigate obtaining federal and state ID numbers.
- 2. cotain legal counsel as to the pros and cons of $\#^2$ and filing state and federal tax returns.
- 3. implementing sound accounting practices.
- 4. surveying the Mid-America Fellowship in regards to its fund practices.

The information gathered by this work should be benificial to the MRSC, its Areas and Groups. I am asking for your financial, physical and spiritual help in these matters.

While attending the conference I became aware of how grateful I am to be a member of the Mid-America Region. Our spiritual maturity became evident to me. I at all times felt your complete confidence in John and I to represent your wishes and make decisions in the best interests of Narcotics Anonumous as a whole. This surely comes from a deeply seated belief and faith that N.A. will proliferate. We seem to be free of the fear that catastrophe is eminent. This allows us to be progressive in our twelfth step endeavors. (God hasn't brought us this far to drop kick us out of bounds).

The week at the conference was physically draining. However, it was spiritually invigorating and very educational. The accomplishments to date and the plans for the future speak highly of this fellowship. If I can convey only one aspect of what I found at the conference, this report will be its own success. Individual ambition, motivation and determination united in our spiritual principals is able to truely envision, "no addict seeking recovery need die without a chance to find a better way of life".

John has asked me to report on the WSC Literature Committee. Since Motion #16 in the Conference Agenda Report for 1989 carried, I have

applied for general membership to the WSCIC.

I attended both committee meetings during the conference week. I have discussed what took place in these meetings with our RSCIC this morning. I have asked their approval for me to write a personal letter to the WSCIC. The purpose of this letter is to express my concern about their becoming too bogged down in technicalities, thus hampering their ability to produce literature.

Bryce Sullivan, who had been vice-chair of WSCLC, was elected by the conference to chair the WSCLC for the upcoming conference year. As I mentioned earlier motion #16 carried as did motion #15. Motion #17 (Group Starter Mit) was committed back to committee. Motion #18 (1989-90 "A" List) was amended to:

1) The Steps portion of It Works: How and Why

2) For Those in Treatment

3) In Fines of Illness

b) M.A. Group Starter Kit

The traditions portion of It Works was committed to the Board of Trustees. I want to commend the liturature committee for gracefully relinguishing this. WSCIC general members will work on the daily meditation book, unless otherwise requested by the WSCIC.

The earlier mentioned attitude turns my attention to the future. Knowing John's ability to surmarize and inform you of what transpired at WSC 139, and not wanting to be repititious, I'll spend the rest of my re-

port looking at the uncoming year.

I would suggest that we take mack to our Areas and Groups the means of obtaining information about our fellowship. These being the N.A. Way, Newsline, Fellowship reports, and our own Newsletter. I personally see no reason not to pronote these tabloids. I would like to see the Newsletter

become an open forum for communication within the region. We might even wish to put other regions on our mailing list, on a reciprocating basis. Committees and trusted servants could use this avenue to entice the fellowship to become more involved. It could be used to express problems and points of interest, inviting feedback.

I think we need to look, again, at our format and agenda for RSC meetings. We might consider having all sub-committees meet sinultaneously. This could help promote deeper involvement and more expertise in committees. Two day RSCs could be re-evaluated. Interim meetings could be held, if there is a need for them. I certainly encourage more communicatin amongst us and will try to do so myself. Many ideas are brought up and voted on at our quarterly meetings. After having time to reflect on these matters, my opinion and attitude sometimes charges on these matters. It would be good to have time to consider than before and.

As the question of funding our trusted servants remains an issue, I believe we need to formulate written policy on this matter. I'm wondering if this is the reason I hear negative remarks about the way we spend our money. Let's bring this issue out and discuss it open-mindedly. An understanding of the responsibilities of world level trusted servants might help.

World level committee members gain admitance to committees by different means, depending on the policies of the committees they seek to serve. Expenses are also covered in varying amounts. Although these individuals may be active members of this body and/or reside within this region, when they gain membership to their respective committees, they are not representatives of this region. They then become directly responsible to the entire fellowship of Marcotics Anonymous. If we decide to support these members financially we should do so because we believe in and have faith in the aspirations and endeavors of the world level service body. In general, these committees are becoming more selective in who they accept as members. If we are as selective in our process, N. A. will be served well and our money well spent. The above does not necessarily pertain to our committee chairs, RSRs and alternates. I refer you to page 4, first two paragraphs fo the WSC '89 Chairpersons' report.

I feel it would be a shame not to support these members who meet the criterion. So that my notives may be judged, I will express my future intentions. As a general member of the WSCLC I intend to become an active participant, Next year, I intend to seek voting membership in this committee.

I hope that in the coming year the policy committee, in cooperation with the other committees and the treasure, can propose a vorkable budget. It is imperative that we utilize our funds for the optimum benefit and be an active supporter of the fund flow system, at both ends. Again I refer you to the WSC 189 Chairperson report-Finances and resource management.

I see great potential and much to be accomplished by all the sub-committees. I think we sometimes become routine and mundame in our committee work. It was refreshing to see P. I. s' ambition and motivation on their projects last year. I hope the incoming chair continues with that progressive attitude. I would advise all of you to comunicate and inter-act well with the other committees, so as not to overlap or confuse our efforts. More workshops and learning days could surely be initiated.

We might also start discussing how we will deal with the conference

agenda report next year. I have a few alternatives in mind and will converse with you about them in the interim.

I would like you to consider lengthening the terms trusted servants may serve. After trying to integrate myself into a complex system at the WSC I can appreciate the usefulness of one who has accumulated experience. We have adopted a system of rotation to protect our selves from power struggles and manipulation. I wonder if it is really wise to put our experience out to pasture. We seem to believe it is right to hold several positions at once, if we only hold them for a specified period of time. Then many of us move on to hold other positions, becoming "jacks of all trades, masters of none"? I realize longer terms mean deeper commitments, but then, commitment is an integral part of recovery. Hopefully our past practices of waiving suggested requirements will soon become a thing of the past. As our fellowship grows, our accumulated clean time and experience grows. I feel this committees requirements should be broadened to include greater experience, competence and proven reliability.

Reading the area minutes has helped me keep in beat (or out of beat) with what's going on in the region. I thank those of you who have been sending them. I encourage you to continue, and these who haven't to please start. I hope to attend as many area meetings through out the region as possible.

I have passed out a sample form for surveying the regional fellowship. I am asking for your input on this type of survey. Do you have any questions to add or delete? Is it understandable? Is it apropriate? To you see any value in doing it? It may prove to be a useful tool or of ne merit what-so-ever. However it turns out, your positive cooperation will help prove the final analysis.

I would like to encourage the regional fellowship to become more accountable in matters of finance. I refer you to the WSO '89 report, page 65, - Fellowship Finances. My efforts to conform to this request are reflected in the treasures report submitted at this meeting.

While insurance, thru WSO, is not available yet----. They do encourage us to check with the facilities we use as to their insurance coverage. This could be a deciding factor in our choice of what facilities to use for our functions.

I see a wealth of human resources with-in the Mid-America Region. We have a great deal to offer to our membership and to those who are not yet acquainted with us. There are those of you whom are capable of serving at the world level and I encourage you to look toward that means.

When dealing with the proposals of the upcoming year I urge you to practice one of our basic spiritual principles, open-mindedness. Whether these proposals prove to be functional or not the motive behind them is right a to improve er service structure so as to better serve the Fellowskip of Marcotics Anonymous.

As it is, by precedent, time for us to elect an RSR and alternate, I would like for you to consider what I said earlier about utilizing the experience of our trusted servants. I propose that the RSR and the RSR-alt, be elected to two year terms contingent on their annual terms being ratified at each May RSC.

To iplement this, I suggest that you either;

1) re-elect John B. to his second one year term (he has served us well) and myself (or another member of your

choice) to a one year term as RSR-alt.

2) that you elect myself (or another member of your choice) to a two year term as RSR and another member of your choice to a two term as RSR-alt. *

*the rer-alt, would be committing to a four term of service

I have thought long and talked openly with other members before making these proposals. Whether you accept or reject them, I will accept the decision of this body and continue to serve at what ever position you choose.
