### RSR ALT. REPORT:

Expanding the We

We Are Responsible

My report will be in three basic parts.

- 1. Our Regional conscience
- 2. WSC Overveiw
- Suggestions on how we could improve.

## ASR ALT. REPORT CONT:

Our regional conscience or how we got there.

There were only two of the seven areas that voted on the Conference Agenda Report. To my knowledge, no single group had a CAR Workshop. Of the two areas that voted, there were approximately sixteen people involved. Once again our conscience was somewhat hollow compared to all the addicts we have in recovery across our region. My frustration was finally overriden by a sense of powerlessness and I realized that this was our consience for this year. In the last section of my report I will address some suggestion on how we may improve our efforts since we have less than a year to get ready. Many of you who have read my reports will notice I sometime raise questions that I do not offer an answer. As a region it is important not to have all the right answers but better to ask the right questions.

#### WSC OVERVIEW

I will try and highlight what went on at the WSC. If my report somewhat overlapses with the RSR's I will omit that portions durning my oral presentation. As the title of my report indicates we need to expand our scope of the concept of WE, Even though it was not an offical part of the WSC the international forum were attended by representatives from Germany, England, Ireland, Australia and Mexico. As they discussed the growth of the fellowship in their respective countries they face many of the problems we do here in Kansas. Even though they still need guidelines for forming a Service Structure, they want recovery information more. The members of the WSO staff who have traveled there state that from the time they get off the plane until they leave its questions and more questions. The World of N.A. is divided into those who can speak and read English and those who can't. The non English speaking portion of our fellowship is desperate for recovery in their native language. This problem also effects parts of the U.S. fellowship. There also exist religious, racial and ethnic prejudice where people only attend meetings with their own kind. Just like in the U.S. money or lack of it is a real problem. With the uproar we have had about a cheaper basic text in some of these countries our Basic Text can cost between \$20 and \$50 dollars when customs and taxes are added to the \$8.00 dollar price.

## THE CONFERENCE AGENDA MOTIONS

If anyone is interested I can make a motion by motion synopsis of how the vote went. However, I will address the major events and offer a brief description of their impact.

- 1. WSC and WSO are running on empty cash flow. Although there has been more money donated to the World than anytime in our history. We are still short of funds. We were asked to list in order of importance those discretionary items that will be funded if the money comes available. Enclosed in my report is the list. It is clear that these projects would help us carry a stronger message to more people if they were funded.
- 2. The Basic Text motions. All of the motions that delt with the Basic Text failed. The prevailing attitude was one of faith that allowed for us to arrive at our 5th Edition. the 5th Edition is the accepted version of our text and will not be revised for four more years, if it is felt we need to do so.
- 3. A single point of decession when the WSC is not in session. Since we meet for a week each year there araises certain emergencies that must be acted on before we meet again. The illicit Basic Text was one such matter from this past year. There is an AD HOC Committee that will make recommindations in the coming year.

- 4. The World Literature Committee. There was much concern and some impatience about the steps portion of 'It Works How and Why'. The first three steps are out for review. There was a suggestion to give the steps to the trustees who are already doing the Traditions. Some wanted to toss it all out and start over again. The discussion on the floor was about the staff team writing approach vs. the lets let the fellowship write the thing like the Basic Text. If the initial reaction to the first three steps is largerly negative we may be back at square one again. The WSO is looking forward to the book to help increase the fund flow with the leveling off of sales of the Basic Text. However we need a book that enhances our recovery more than we need that vision of fast money. Something like in GODS time not ours.
- 5. We have the opportunity to go over much information in the coming year. There's the first three steps. The first six traditions and our daily meditation that will probably be in its approval form. Along with the pamphlet In Times of Illness. I'm sure there will be some work on the Guide to Service. As a Region do we have the willingness or will we do nothing like we have on so many other projects in the last few years. This does not say anything about the ongoing projects in P.I., H&I and of course a campout and convention thrown in for good measure.

As we look at all the work that needs to be done it becomes evident that we do not have enough people active in service to do it all justice. As a Region we should begin to set some priorities to do the most important projects with the help we do have.

# HOW WE CAN IMPROVE

I talked to several GSR's and they had no idea at how much time it would take to do the CAR in a comprehensive manner. Since these Trusted Servants have a short amount of clean time, part of our responsibility is to educate them on how to do the CAR and also on how important it is that every addicts voice be heard. If they express willingness we can put together a learning day to address this issue. I feel this also holds true for area level servants because they provide guidance on matters affecting their specific area of concern.

One thing I noticed at the WSC is that trusted servants have a commitment to a single fellowship. If the people we consider do not have that signalness of purpose we will be ill served.

A final note in passing. One of the ill fated Policy Committees recomendations for the rotation of RSR's and their alternates is like our region. I learned much during my first WSC but in order to be more prepared it will take much study to stay informed on the issues facing us in the coming year. As we enter into a new conference year I hope we can come to an awareness of the We in our Steps that does not just include addicts in our Towns, States or Nation but any addict in the World.

N.A. has but one primary purpose to carry the message to the addict who still suffers. Let us open our hearts and give of our time and our money. We are responsible.


