WSC Quarterly Comments by Committee Attended.

I will not try to discuss Public Information because Anita will cover what happened in her P.I. report.

H&I The H&I panel tape is near completion and will be out in the near future. When it is finished it will be available by itself or when you order a copy of the H&I handbook. The committee now has an AD-Hoc on revising certain sections of the H&I handbook. The committee is becoming involved with H&I as it pertains to a World Wide fellowship. As always they continue to review and revise as necessary their internal guidelines. The major sticking point is election of pool members to voting members status. They will no longer pull names out of the hat. Any voting member whos term expires will have all the privilages as a pool member, if they continue to participate.

Literture; The work load of the committee for our confrence year is staggering. With the fellowships desire for a book on the steps, they did much work at the quarterly. They also are moving very fast on the daily meditation book, If the input on this project is positive, the daily book may be in its approval form this conference year. Since the quarterly the steps ad-hoc has gone over the drafts of the first nine steps. As this project continues to progress they had to go back and do some re-working of steps one, two, and three. This was done because the staff writer is no longer working on the project. The last information I recieved is the first six steps will be in approval form draft soon. They have suggested that the review time be six month. This last item is subject to change.

<u>Policy:</u> Since the conference, without much confidence from the fellow-ship, the policy committee has been working on many projects. The one sure to generate the most controversy is the sitting of new regions. They will propose a four point plan to allow time for a fully developed plan for conference approval.

The most significant aspect being, to freeze setting new regions until the conference approves a plan. More will be revealed.

Board of Trustees; Durning the time I was in their meeting, they had a major discussion about the working relationship with the new exective director of WSO. The trustees and the chairman of the Board of Directors wanted to make sure we did not create another Bob Stone situation. They are pleased with his work so for and they want to do everything they can to insure that the efforts of WSO run smothly. From reading the minutes of the Trustee's minutes since they quarterly I some times wonder what language they use.

 $\overline{\text{General Comments}}$ ; How many areas have reviewed "In Times of Illness."  $\overline{\text{Get a jump on the CAR}}$  and do it soon. Also how much have we done on the daily book and the Steps and Traditions. It is my hope that MAR will not be surprised when the final drafts come out.

The Multi Regional Learning Day is progressing rather well. We could still use much more support from our region.
