Here is the letter that the Dave R. From FFF handed out:

Dear brothers and sisters of the Mid-America regional floor.

We first wish to thank this region for its support and patience through our periods of growth, especially the times that do not look like growth. The Fellowship for Freedom Area and its subcommittees have been experiencing many changes, with varying degrees of conviction. The Area convention being at the forefront of controversy at this time. While various members of the area disagree with the leadership of the committee, the area as a whole still supports the Area convention. The convention committee is arranging a time and place to answer any questions posed by groups or individuals regarding the conventions activities and/or expenditures.

What we ask of you is to provide individuals willing to mediate and chair this function. With all due respect these are the qualifications of your members we wish to see:

- 1. At no time have they ever been a member of this area or group.
- 2. That you choose members of the least bias of the FFF area and it's activities.
- That this group have at least one member of the steering committee and at least one member of the regional convention committee and at least one member of the regional committee.

Our purpose is to render ourselves accountable to not only our area, groups and individual members but also to this region and surrounding areas. We also hope to use this forum to begin to patch some of the differences we have that stand between us and the area we can be. In the past we have not gone out of our way to keep the lines of communication open between our area and this region, but there are many of us here that wish to mend our past relationship and look to a more fruitful future, where we can work together to further the efforts of recovery in this State. Together we can be a formidable foe against the disease of addiction but while we squabble amongst ourselves the addict who still suffers, die.
