RENTAL RULES FOR THE MCPHERSON COMMUNITY BUILDING

1. Rates:

Double rates will apply to out-of-town persons requesting use, and, on city observed holidays.

- 2. Cancellation Notice If cancellation is made with less than one (1) hour notice during the day and or after 3 o'clock p.m. for evening use the minimum charge will be as for one hour usage. The charge for "No Show" will be as for the time requested.
- 3. All props, equipment or other personal property brought in during rental must be removed at the time the premises are vacated. If not, rental will be charged at the hourly rate, not to exceed the daily rate, until all items are removed. The city may make additional charges for special and additional clean-up, at the rate of \$20.00 per hour.
- 4. Any youth activities must be arranged, scheduled and supervised by adults, (persons over 21 years of age.)
- 5. Activities of an unusual nature will be checked out with the City Commission before reservations can be confirmed.
- 6. NO SMOKING, ALCOHOLIC BEVERAGES OR DRUGS of any kind are allowed in the building. NO OPEN FLAMES or other incendiary devices (other than gas cooking devices)
- 8. The city will not be responsible for any loss of articles sustained in the gym, dressing rooms, etc.
- 9. All EXIT DOORS shall be free and clear of congestion at all time. There shall be no more than one hundred (100) persons standing on the main floor of the auditorium and not more than fifty (50) persons standing in the auditorium balcony. Persons standing shall not stand in the aisles or near exits.
- 10. No Chairs are allowed in the balcony of the gym.
- 11. No plastic or similar tape is to be used and/or attached to the gym floor.
- 12. No equipment, belonging to the city may be removed from the building.
- 13. Any props to be used on gym floor must have prior approval.
- 14. No loitering shall be permitted in the lobby or upstairs hallway during a performance.
- 15. In the event of anticipated capacity crowds, the Fire Chief shall be notified in advance to be certain that no safety precautions are overlooked. Occupancy limits will be strictly adhered.
- 16. Arrangements to meet with a custodian concerning various details, may be made by calling the City Clerk's office, 245-2535.

This will supplement the Regional meeting list"

Maker: Public Information subcommittee

Intent: To provide accurate information consistent with our Public Information guidelines, reduce the chaos, as well as be financially responsible to our Region.

Financial impact: Minimal

Disposition: Automatically goes to Groups.

Discussion: Question: when was the last printing of wallet cards? Answer: over a year ago. Cost? \$300.00. It was brought up that all the information on the wallet cards could be and is on the meeting lists. It was then pointed out that it is easer for people to carry wallet cards than meeting lists.

Motion: The 2006 convention be held in Hays Kansas on April $7^{th} - 9^{th}$. **Maker:** Steering committee **Disposition:** Motion passed; we will be in Hays in 2006.

Motion: Have the secretary reproduce the policy manual for the Mid-America Region incorporating the changes to date, and send it

to Jeanie M. for printing.

Maker: Debby S.

Intent: To provide Regional Service Committee members with up-to-date policy manuals and help defer confusion.

Financial impact: \$500.00 or less.

Disposition: Motion passed. (I will try to have the work done and to Jeanie before January 1st)

Discussion: Questions were raised concerning the advisability of doing this now when there are positions and subcommittees that need to develop guidelines. It was pointed out that the steering committee had proposed and the Fellowship agreed that the policy manual should go to a four year printing cycle because it was thought that the Region was beyond the need for annual or biannual printing. We were wrong this time and there will be repercussions from our changed accounting system for years to come. It was felt on the floor that this needs to be done at this time in spite of the shortcomings that will be in it.

Motion: Create a new Regional position, the position of Regional Archivist. 3 years clean time, willingness to serve and have the time, skills, and energy to catalogue Regional archival material.

Maker: John S. III

Intent: To help preserve our records and memorabilia for our future.

Financial impact: Unknown

Disposition: Motion passed and goes to Groups.

Discussion: It was pointed out that this individual does not need to have storage space as the Region rents a storage unit.

Motion: In order to change Regional policy, 2/3 of all seated Areas must agree to the change.

Maker: Kirk B.

Intent: To clarify policy

Financial impact: None foreseen

Disposition: Motion passed and goes to Groups.

Discussion: It was pointed out that historically it took a 2/3 majority of the Areas present to change policy and it took 2/3 of the seated Areas to conduct business. If passed, this will require 6 of 8 Areas agreeing to policy changes to go into effect no matter how many Areas are present. Another words, if 6 Areas are present we can conduct business, but it would take a unanimous vote to change policy.
