Business Meeting Minutes Feb 16th, 2015

The business meeting of the Mid America Region of Narcotics Anonymous was opened with a moment of silence by the Chair at 8:07 am. The 12 Traditions were read by Rod D., and the 12 Concepts were read by Sally R. All Attendees introduced themselves.

The co-chair read the minutes from the August RSC Meeting. The chair asked if there were any amendments to be made. Minutes were accepted as read.

She stepped out of her comfort zone to try out the position and did a great job by making sure to provide our Area with information about what was going on in our region as well as letting this body know what was going on CKA.

Our Area continues to hold meetings in Great Bend, Hays, Larned, and Stockton. The Larned group has moved to a new location, 501 Main. Our Area has a new information line number. 620-603-0920. The reason for the phone number change is that our toll free number began being bombarded with spam calls from the East Coast, increasing our phone bill significantly. Communication with our provider revealed that this has been a problem for many companies and organizations with toll free numbers recently.

We have already cut back from twice a month to once month and if a volunteers gets sick, has to work, or something else comes up, it jeopardizes that commitment as well. Only four men are currently active in this service, and women volunteer level has fallen below the minimum required to carry the meeting. Two volunteers have turned in certification paperwork for the Jail meeting so hopefully we can get this meeting going again. At this time we do have sufficient volunteers to carry the meeting to the First Step facility.

P.I.

Public Information service is happening at a gratifyingly high level in the Miracle Area. We have distributed literature racks stocked with I.P. pamphlets at several medical facilities and pampllets are being taken to several more. The sub-committee members and volunteers cooperated in the recording of several Public Service Announcements on local radio stations, and we have received calls on our "help line" from addicts and loved ones of addicts who have heard the announcements. It works!

In a cooperative effort, the P.I. subcommittee and Activities subcommittee are sponsoring a P.I. Learning Days workshop on March 21st.
