Business Meeting Minutes May 17th, 2015

The business meeting of the Mid America Region of Narcotics Anonymous was opened with a moment of silence by the Chair at 8:02 am. The 12 Traditions were read by Wayne S., and the 12 Concepts were read by Beth N. All Attendees introduced themselves.

Housekeeping: The Chair called for all requests for funds and motions to be turned in.

Roll Call: We took our first roll call and the following chairs and trusted servants were present at the start of business on Sunday

Primary Purpose Area and Western Area have missed 2 consecutive RSC Meetings, are not considered part of quorum.

A. Approval of Minutes:

The Secretary read the minutes from the Feb RSC Meeting. The chair asked if there were any amendments to be made. Amendments were suggested. Minutes were accepted with amendments.

B. Area Reports:

Central Kansas Area:

Hello Family,

We continue to do as much as we can with the human resources provided by the groups. We have two groups who are consistently active at the area level and are providing not only the human resources but most of the financial resources as well. A group of members was sent to offer support to one group who had not attended area in a couple of months only to find that the meeting didn't take place that night. We have sent letters to that group and they will likely be removed from the meeting list as we do not know how often listed meetings are taking place. The other meeting has been sent letters as they have not attended an Area in 10 months.

Anyway, despite those concerns we continue to carry an H&I meeting into the Barton County Jail twice a month, once for the men and once for the women. We also continue to provide an H&I meeting for the Ellsworth Correctional Facility and are extremely grateful for the new volunteers from outside the area who may make it feasible to offer some support to Larned Correctional Facility sometime soon.

Our next CKASC falls on the same weekend as World Convention so we are planning to have our meeting early on June 13th at 3pm so we can try out the next streaming speaker options at 5pm. We are also going to have a pot luck so if you want to join us we will be at 1910 17th in Great Bend.

There are some events coming up in CKA. The Great Bend "Living by Faith" group is having a day in park on June 20 in Vets Park, starting at 3pm. The Larned "Just for Today" group is planning their 16th Annual Rib BBQ on September 26th in Schnack Park. Both of these are posted on the regional website.

CKA voted yes on all 9 policy motions and yes to support SBTW. On the logo motion, one group chose option #1 and the other group chose option #2. I don't know how to get a vote out of those results.

We also have a \$50 donation to the region. This was accomplished by going into our prudent reserve. I don't tell you that for sympathy but to express how important we feel it is that we support the efforts at this level as much as we can. Our current situation really highlights the importance of passing on those resources to the service bodies in the structure.

Hello family,

Once again I want to thank MARCNA for allowing me to set an archive display up. Originally I was told I would have a middle table, so I didn't bring anything that would require wall assistance, like the mini banners and t-shirts. As it turned out I had an entire room to work with, which allowed me to spread what I did bring out for better view.

While at MARCNA I was entrusted with items for archives from Carl K. Included were four coffee cups, MARCNA 1997 and '99, the basic coffee cup, and the group shares Jimmy K. logo cup; a 2nd Edition Basic Text; 1987 approval form of It Works-How and Why; and finally a 1993 limited edition It Works-How and

Why. The cups were stored in the storage filing cabinets, but due to the nature of the books they are being stored with the media in a controlled environment (my basement). I also have received all merchandise from the MARCNA committee, current campout committee and current Soul to Soul. In place of the full CD set for MARCNA an mp3 flash drive was given.

Another thing I am entrusted with at each MARCNA is six full-size banners, which I seem to be missing one. The five banners I do have, by year, are 1983, 1984, 1991, 1992, and 2003. Since I am unloading and setting up archives while these are unrolled and hung, I am not sure what year is missing. MARCNA XXXII was a great success! The hotel was wonderful and accommodating at every turn. Even at final billing they worked with us. Our final bill with the hotel was \$8932.73. This was paid in full on the Thursday following the convention.

Overall I had a wonderfully supportive committee however there were a few bumps in the road. I am really grateful for the experienced members who helped and led me through this experience. Public Relations:

Hello family,

We had a large group in attendance at yesterday's PR meetings but only needed to have two work groups meet, either due to lack of coordinators or just nothing to talk about in the others.

The Phone line work group met and updated the changes from the meeting list onto the phone.com site. There were some errors found and Tracy was going to make sure that Megan gets the correct information. There was a member present who asked about training for taking live calls. This work group has really embraced the idea of using this time to WORK on getting the tasks completed, bravo to them. The presentations workgroup completed the presentation to professionals on April 10th in Wichita. We had 7 professionals in attendance, a drug court judge and her assistant, 2 staff members from the juvenile detention

center, a counselor from the veteran's administration, as well as counselors from local treatment centers. There were also 14 NA members who signed in but I believe there were some who were in and out of the room during the presentation. We received very positive feedback from the professionals in attendance and likely could have had a longer discussion if the clock had not run out on us. Most felt that their understanding of NA was significantly increased but there was still room for further information to be gained. They were very likely to recommend this presentation to their colleagues and very likely to utilize the materials provided. The only negative feedback was they wished that more local members would have been present.

The total cost of this event was \$496.86. I can give a breakdown if anyone is interested but if not I have turned over my receipts to the treasurer and returned \$134.34 from the \$394.00 check and \$94.27 was returned from the \$300.00 allotted for the use of hotel electronics. These amounts should be returned to the PI escrow for later use. It is likely that our attendance would have been better if we were able to offer Continuing Education Units to our licensed professionals who were invited. Perhaps a work group to investigate that would be beneficial if we are going to do further presentations. We did look into it but the process is going to be time consuming and we were focused on planning this event. If there is any interest is doing that work, I have some contacts who might be helpful.

So, what now? This workgroup is asking the regional floor if you wish for us to continue or if we will be dissolved now that our task was completed? We feel that we need the okay from this body to continue.

If we continue, the next task we will plan is a Presentation on the Friday prior to the Zonal meeting in January 2016. We will have our first conference call / digital meeting on Thursday May 28, 2015 @ 7pm. I will finish the presentation report by expressing my deepest gratitude for everyone who participated in making this event happen. There are way too many to name and I would surely forget someone. It was a great honor to be involved in this event and I don't really have to words to describe how I feel. Pending the outcome of the regional policy either PR or PI will be open at the next RSC, please announce this at your areas. Some work group positions will also be available in August.

Tradition Book Project update: The Tradition Book project is entering another phase. Introduction and Tradition 1 review and input finished up at the end of January. Traditions 2-6 are out for review and input with a deadline of May 31. Front end input is completed. Traditions 7-12 should come out for its review period June 1 and have a due date of August 31. For more information visit, www.na.org/traditions More recent NAWS information. Another bulletin has been put out by our World Board in regard to group conscience and NA literature. This can be found at www.na.org/fipt. Also the new guide to world services is here. I also received the draft summary from 2014 WSC, and recommendations from the parliamentarian, Don Cameron. The recommendations from the parliamentarian for the future of the conference include use of electronic voting devices, as well as addressing issues like the need for more clarity in written motions and proposals, to distribute more equally those who are called on to address the conference, actions by the cofacilitators taking too long on the floor, the on-going confusion about "motions" and "proposals", and the need to adjust to the needs of the non-USA delegates. MZSS has received support to continue in the process of gaining approval. They have sent out a proposal that will make this a biennial. As our region has previously shown a considerable amount of support for MZSS and has already donated funds to seed future MZSS events. So I would like to just reaffirm this today to return our vote of support to the workgroup.

As for Plains States Zonal, Nate and I are awaiting your responses on the Sponsorship Behind the Walls proposals that you was to be taken back to groups this previous quarter. The next Zonal meeting is the last weekend in August. The dates for this meeting are August 28-30th. It will be in Des Moines. There should be more information out soon. Also it will be our turn to host the Zonal meeting in January. The request of the Zone is that we hold this either the weekend of January 22nd or the last weekend January 29th. This is to allow for the WB to have met, in January, and be able to give us information on CAT. This will be a CAR/CAT again. It would be best to hold the event in a location that is close to a major airport as to allow for easy travel for anyone who will be flying.
