Like any ongoing accounting, this document will always be up for revision every few years or so, depending on the amount of changes that transpire. There is always the possibility of old minutes, newsletters or reports that may alter or add to this latest edition, but is unlikely. The second item is a donation of two t-shirts from Daniel C. The first shirt is from the 2nd State Roundup held in Wichita Nov. 1985. An RSC meeting was held at this function and the H&I committee made special t-shirts that said "I Get High On H&I" that were also sold. The 1st State Roundup was held Feb. of the same year and then in March MARCNA was at Tulsa, OK. The second t-shirt is from the 1988 Mid-America Convention in Kansas City, KS. The significance of this convention is that it is the first MARCNA held in Kansas. After having the first four conventions in Missouri and Oklahoma, a Kansas convention was in the works for 1987, but kept getting delayed until finally happening Feb. 1988. The registration flyer labeled this as the "Kansas Mid America Convention" and was considered the first. To support this "Kansas" convention the Great Bend group took over the Chili Feed and held it in Ellenwood as a fundraiser, that annual fundraiser lasted many years. The next year's MARCNA picked back up the original four, and was listed as MARCNA VI 1989 here in Salina. These two shirts will be placed over cardboard cutouts and displayed with the rest at MARCNA, when I have the proper space to do so anyway.

Public Relations:

Hello family from Public Relations,

We had another productive PR meeting yesterday. Here's the scoop on what's happenin'

Media – Megan transposed numbers when she ordered meeting lists so she ended up with 285 instead of 825. She worked with the treasurer to make out a request for funds to order the difference to get those meetings lists to those areas who did not get theirs. This workgroup did not need to meet today.

Hospitals & Institutions – Alan reported that this work group is focusing on how to get more people involved. They also want to make sure that those doing H&I or interested are getting the appropriate orientation. Some of their goals for the future are to put on a learning day or workshop and provide a place to share what is going on and give information to help other areas.

Phone line – Nate reported that most of the changes were made to the phone line prior to the RSC due to the media coordinator getting the information to him early. One group was taken off mistakenly due to being taken off of an area list but that was fixed. This work group discuss unused options we are currently not utilizing but that are available such as a free conference call option and being able to call from a link on our webpage. There was also more discussion about how to increase interest and volunteers for the live addict option. There are plans to try to set up tables at the RSC functions to encourage more people to volunteer. Web – There is still no interest in taking this position but possible interest to learn. Daniel is willing to continue work to develop a new page and work with volunteers who want to learn. He is having a remote meeting soon so get with him if you are interested.

Presentations – Beth N was chosen by this workgroup to be the new coordinator but they are still in need of a secretary. This workgroup had a new task brought for consideration. There is a drug task force project in Hutchinson with monthly community forums taking place. Tim K has stepped up to lead a small project group to make the initial contact and find out if they would be interested in having an NA presentation at one of their meetings in the future. The workgroup is also working on the upcoming presentation in Lawrence prior to the Zonal meeting next January. There are volunteers working to obtain a way to allow us to offer continuing education units to the professions that attend these events. We had a couple of options to consider, one is \$100 for a one-time event or \$350 for 3 years of events as often as it could be held. They will be having a conference all meeting on Sept 3rd at 7:30 pm. In preparation for these upcoming

presentations, there will be a strong effort to gather current stats from around the region. Rod D will be reach out to members to survey addicts at functions and home groups around Mid-America between now and December. If you are interested, please talk to him.

In addition to all this great work, we also held elections. Please congratulate Jeffry L as the new PR Cofacilitator, Ed B is the PR secretary, and Beth is the new presentation coordinator. The committee affirmed their on-going support for the current work group coordinators. We were uncertain of that dates to use when figuring start dates for these positions, does everything start over since the new policy has passed or are their terms started at the time of the original election. The committee would like to offer Sally R aka me to be confirmed on the floor as the PR facilitator.

At the conclusion of the meeting we planned to check out the region's display but the new one that John S made is not in the storage unit and seems to be missing. We had heard that the display was damaged and needed to some attention. Does anyone know where that display is? This display needs to be located so we can ensure that we have it to use when we are doing presentations, we also want to make a positive first impression.

There were questions about having a process in place for groups that are not part of an area being put on or remaining on the regional meeting list and phone line. Since the meeting list is taken from Area meetings lists and Phone line takes from the Regional meeting list, unattached groups can get missed.

We have requests for funds for the following: \$239 for the webpage &\$350 to certify our presentation for 3 years to offer CEUs.

There will likely be additional requests for funds in November for the upcoming events. The PI escrow account has \$295.79 but there is also an H&I escrow with over \$400. Do those accounts merge or does the H&I workgroup retain that account? Not a big deal either way, we just need clarification.

I hope I didn't leave anything out but I am sure someone can fill in any blanks.
