
- Daniel opened the meeting with a moment of silence followed by the Serenity Prayer.

As many of you know, (drum roll, please...) the new Mid-America Regional Web Site LIVES!!! The site went live last month, and there are the usual hiccups, headaches and speed bumps. Despite these, the site is up and serving the Mid-America Region! Events are displayed on the calendar, and are up-to-date as of Wednesday, 15Nov17. Pages have been created for printable Meeting Lists, for the Basic Meeting List Toolbox "meeting finder" utility, for Mid-America Newsletters, for our Region, Group, and Area history pages, a "contact" page for incoming requests, and MORE!!

Initially, there are some issues which need addressed immediately. Several members in the Mid-America Region have brought to light some problems with the BMLT meeting finder utility. Up front, let me assure the Committee that the problems are NOT resulting in incorrect information from the BMLT. Under certain circumstances, the BMLT will return a skewed selection of meetings, e.g. it will find every meeting of one group, but not find the meetings of another group in the same search area. I can explain this in more detail, but we ("we" being the BMLT gurus Tom K. and Chris M.) are working on the issues. Ahead of this, however, the Convention Preregistration page needs updated and uploaded. I am, as I type this, sitting in the Convention Committee Meeting, and at close, I hope to have a plan for moving on this. The

newsletter page will have the current newsletter displayed on the page, rather than as a link. That page will have a link to the Archives. Minutes from RSC will be similarly done.

I am documenting the procedures used to upload all information which will be used to maintain the page. This will be available to all on a need to know basis. For the present, we would like to do the updating of meetings, lists, events, etc. as a committee, rather than having groups, areas, or addicts do this. We are open to discussion on this. All information for the Web Page should go to <a href="mailto:info@marscna.net">info@marscna.net</a>. Committee members will direct e-mails to the correct box, and will update any information as requested. Note, if you are sending a request to update information on the Web Site, PLEASE MAKE THAT CLEAR UP FRONT!! We don't want someone to forward an e-mail and find out later that there was an event or a meeting change that was discussed towards the end of the e-mail.

When the issues discussed above are tended to, we will begin adding prettiness and new features. With the Basic Meeting List Toolbox, we also gain the ability to coordinate the printed Regional Meeting list and the NA World Services meeting list with our Web Site, and we will be looking at this immediately. We also will be welcoming new members to the committee, as Mike G. of Wichita has joined the charge. On this, we will welcome any and all assistance, support, well-wishes and well-wishers, and others who want to help the Web Service Sub-Committee – geeks are especially welcome!! #### **Officer Reports:**

#### Regional Delegate [RD]: Plains States Zonal Forum

Funding for SBTW. They need about \$1300 for 2018. Current zonal policy isn't really setup for a long term, large scale program and the Zone is looking for guidance on how the Regions would like to change the zones guidelines. Funding Motion for \$1310 passed.

SBTW – Flyer that was sent to prisons, and introductory letter was asked to be hung by prisons. The letters are in English and in Spanish. If you know of bi-lingual members who want to be a sponsor, that would be great. Working to

translate other documents to Spanish. Anything in written documents that needs to be talked about? Just need a check in from the regions to make sure they are going in the right direction. Question was asked if annual refresh training will be online. This is one of the duties of the regional liaison to set that up based on Human Resources. Discussion on how they will track to make sure balls aren't being dropped. Budget: \$1310 is being requested. There was discussion on how sponsors will provide literature.

**Proposal** for \$1000.00. Would like to see a number of what will get through to February, and would like an annual budget. Suggested to set up a guidelines workgroup. Minimum needed thought Feb would be \$350, but \$1310 is what is needed for a year. If regions oppose the full amount, she can give money back in February. Suggestion to go ahead and give the full \$1310. Budget may change from year to year. Proposal will be in New Business.

SBTW – Proposal to give \$1000 to SBTW for annual budget. Amendment was made to give \$1310 and bring back what she doesn't use. – Proposal Passed. Discussion on putting together guidelines and to think about on how the money can be handled for this going forward. Too early to put together guidelines, once the project gets established, will put together a workgroup to put together policy. Take back to regions, what does your region want on input on what services the zone is doing.

**Proposal**: Talk to regions and ask if they are okay with us creating guidelines that allows the zone to budget for ongoing projects that are approved by the regions. — No opposition to take this back to Regions.

Zonal Representation Motion – 0-6 Vote. Motion Failed to send Zonal Representation to WSC. Facilitator will contact NAWS to let them know we will not be sending anyone.

BMLT for Zonal Website – Vote – 4-0-2 – Motion passed.

Next Zone – Lubbock, TX – Feb 2-4, 2018. Will be a CAR workshop event. Facilitator has already sent in the request to NAWS for be there. It was asked if it is okay to do speaker meeting. It was discussed that a lot of the time the NAWS representation is the speaker. PR Presentation will be on Friday, but other than that there will not be any other presentations.

PSZF to revisit in February about zonal representation at the WSC.

Fall 2018 Meeting @ MZSS. Discussed having zone at Omaha after MZSS due to being such a busy year w/ the conference, WCNA and MZSS all in 2018. It would be lowa's meeting on rotation. Iowa would be willing to swap out in rotation w/ Nebraska. Dates are November 2-4, 2018 for MZSS. Suggestion not to have Iowa or Nebraska give up their zonal slot, but it would mess up the CAR meetings in Regions. Keep in mind elections will be at this zone. It was decided to have zone at MZSS.

The facilitator and co-facilitator decided they will go to the storage unit before next RSC and inventory and divide it all, either two ways or three ways, then distribute it.

Office/Storage Adhoc: Tim S. turned it over to Nate F. and Jon J., who, with Jeff R. toured the Masonic Temple (336 S. Santa Fe) last night, thanks to Jon J. for making a contact earlier that day. With some negotiating, the price for two small closets, one approximately 6'X6'X10' and the other 6'X15'X10', plus a large room for RSC meetings, is \$2,000.00 annual. It breaks down to \$800.00 per year for the two storage spaces and \$300.00 for the large hall per RSC meeting. We currently pay \$912.00 annual for storage and meeting space fluctuates, depending on where we meet. That price is quoted for the first year only though. The building sits downtown with a large parking lot adjoining it. Fast food and other restaurants are nearby as well. There were concerns about children being unattended during our meetings and functions, being a 90 year old temple there are very nice things in it.

Since no policy is affected, and policy stipulates RCMs determine meeting location unless of an emergency then a motion was formulated by Central Kansas Area and 2<sup>nd</sup> by Convention to pursue it. *(motion #111917-001)* passed 9-0-0. If contract is approved, we will need to plan a time with resources to move all contents, file cabinets, etc. to its new location. Nate F. has a truck and trailer, and will be the single point of accountability. Dollies and a good group of strong members will be needed for this move.

Open Positions, take back to groups: Co-Secretary, Co-Treasurer, 2019 4th of July campout location/bid

#### **New Business:**

- 2020 Convention Bid: Only one bid was presented, the Double Tree in Wichita, KS. for April 17-19, 2020. The room rate is \$109.00 per night, at 70 rooms per night. The block would be released Nov. 18<sup>th</sup>, 2019, or 5 months before the convention date. There is a \$7,500.00 (before admin fee and sales tax) food and beverage minimum, and all meeting rooms will be waived if met. All food and beverage must be supplied by the hotel, even in a hospitality suite or function room. If cancelled early, the fines go off what they consider liquidated damages, or \$23,850.00 which will be billed to a card on file (mandatory). It was recommended for all to seek a new bid and return in February.
- Measupport: Discussion on ASCs requesting support, mainly Western and FFF. Jeff R. discussed his visit with Western and continued support, he stated their last area meeting was the first they were

- able to be fully self-supporting. Chris J. gave a brief report about the Fellowship For Freedom area, and Jacob K. talked a little about the Never Alone-Never Again area, both based in Topeka.
- Questionnaire for Members: Two members of the Mid-America Region are seeking nominations to world services. Nate F. is seeking a nomination for the World Board and Tim S. is seeking a nomination on the Human Resource Panel. The questionnaire is more based on questions about the nominees; the nominations themselves will come from the HRP in March if moved to that level. Since the facilitator has been previously used as a reference for one of the nominees he removed himself from this. It was decided to appoint Amber C. as a single point to accumulate thoughts from each RCM, and fill out the "local committee questionnaire" to send in. The deadline, determined by Amber's schedule, is January 31<sup>st</sup> to get form submitted.
- Phoneline Policy/Guidelines: Nate F., Phoneline Coordinator, submitted guidelines to be included in MAR policy. Discussion on how these should be classified and dealt with brought up many questions. It is listed as Policy/Guidelines but isn't written as policy. Per policy, any policy change must go back to groups. Just For Today RCM submitted and Wichita Metro RCM 2<sup>nd</sup> motion #111917-002 to add guidelines as an appendix, and a line stating "see appendix" will be added to page 26. Placed in "PR Duties, #10, b ".
- **WMA Request:** Wichita Metro Area is requesting someone from the RSC to present a workshop on the 12 Concepts at their upcoming Celebration of Recovery (COR) function. Daniel said he would be willing since RD and RDA are quite busy that time of year.
- PSZF Budget Policy: Jeffry brought up a request from the Plains States' Zonal Forum as quoted in PSZF minutes: "Take back to regions, what does your region want on input on what services the zone is doing. Proposal: Talk to regions and ask if they are okay with us creating guidelines that allows the zone to budget for ongoing projects that are approved by the regions." It was mentioned that currently the PSZF sends all but \$1,000.00 to NAWS after each function/meeting. For long term planning on projects that might require more funding, a change would need to be implemented. All projects are sent back to regions for approval and it was stressed that for guideline changes we didn't need to micromanage the zone, we elect our RD team to make these decisions on our behalf.
- WSC Transparency: Just For Today ASC brought up a discussion their area has been having about NAWS transparency, specifically with world convention books. This also ties in with a report Rod D. RDA has submitted from the South Florida RSC and NAWS. Much discussion went in to explaining the Fellowship Intellectual Property Trust (FIPT) and the bulk finance reporting in the NAWS annual report, or their failure to give more details in that report. Miracle ASC has also had discussions with transparency and lack of reporting to the fellowship. It seems the real question is whether other RCMs feel NAWS should be more transparent too? In was agreeable that we support the possibility of Miracle bringing a motion in February, if RCMs can get feedback before the RD and RDA travel to

the world service conference. Preferably, have the discussion this quarter and be prepared "if" a motion is presented at February RSC.

- Items discussed and passed by show of hands during funds dispersion included \$300.00 to purchase a new laser copier. \$300.00 to the RD for purchase of conference agenda reports and conference approval tracks for upcoming workshops, which one each will be given to RCMs and the rest sold at cost, and \$900.00 for RD/RDA travel to PSZF in February. No motion forms accompanied these.
- Items tabled include moving \$300.00 from the general fund to PR escrow for upcoming April 2018 presentation and fully funding one PR and one FD member to the Multi Zone Service Symposium scheduled for Nov. 2018
- Motion to close showed no objections.
- Mext RSC is February 17<sup>th</sup> and 18<sup>th</sup>, 2018 location (in Salina, KS.) to be determined soon.

#### Howdy Folks

Let's recap what has been happening in the News

- South Florida Region has sent back to their Areas asking for conformation on the 10 points of inspection of the FIPT. The RCM's of the Region reaffirmed that they wanted to go ahead but they wanted to be sure the Groups where still behind the 10 points. They are as follows:
  - a) **Concern:** That literature margins, developmental literature, developmental subsidies, and allowances are being overstated by recording the developmental items and allowances at values greater than cost. We wish to inspect all financial records, documents, and general ledger postings to developmental literature, subsidies, and allowances accounts. We also wish to inspect all records/calculations relating to the cost of literature.
  - b) **Concern:** That all World Board expenses are not being reported accurately and completely. We wish to inspect all financial records for the World Board posted to World Board or other general ledger accounts, and any reconciliations to World Board expenses in the financial statements included in annual reports.
  - c) Concern: That all commercial interests in literature distribution centers outside of the United States have not been disclosed or reported to the fellowship. We wish to review all documents, minutes (internal WB and EC) and financial records relating to ownership or interests in distribution centers around the world.
  - d) **Concern:** Customer discounts are not being applied equally to fellowship and non-fellowship sales. We wish to inspect a list of the twenty largest (in terms of annual sales) fellowship and non-fellowship customers as well as invoices to those customers.
  - e) Concern: That all travel expenses are not being reported correctly to the fellowship, and Trust financed travel is not being reimbursed according to the guidelines outlined in the Guide to World Services (GWSNA). We wish to examine all travel-related financial documents (general ledger details, expense reports, reimbursement request forms, travel receipts, etc.) as well as all Executive Committee minutes where decisions were made to exempt room-sharing.
  - f) **Concern:** That the Trustee is not performing its duties noted in the Fellowship Intellectual Property Trust as it relates to the designation and separation of Trust and non-Trust property. We wish to inspect all lists, designations and separations of Trust and non-Trust properties.
  - g) Concern: Credit card guidelines as outlined on pages 34-35 of the 2016 GWSNA are not being followed. Records requested include all EC minutes approving the issuance of credit cards for WSC responsibilities; All signed condition of use forms; Invoices or other accompanying documentation for temporarily issued credit cards, credit card receipts, expense statement(s), and accompanying invoice(s) resulting in card use; and all EC reports resulting from their quarterly audits and/or reviews of WSC credit card activity.
  - h) **Concern:** That World Convention (WCNA) costs are not being reported accurately and completely due to the combining of non-WCNA expenses into them. We wish to review all financial records and backup receipts for all expenses reported for the world convention in Brazil.

- Concern: That all commercial interests in literature distribution centers outside of the United States have not been disclosed or reported to the fellowship. We wish to review all documents, minutes (internal WB and EC) and financial records relating to ownership or interests in distribution centers around the world. Concern: That all World Service Conference expenses are not being reported accurately and completely. We wish to inspect all financial records for World Service Conference expenses posted to World Service Conference or other general ledger accounts, and any reconciliations to World Board expenses in the financial statements included in annual reports.
- j) **Concern:** There is an appearance that NAWS is targeting NA service bodies over non-NA entities in the enforcement of the FIPT as it relates to the online posting of our copyrighted literature. We wish to inspect all Digital Millennium Copyright Act (DMCA) takedown notices sent by NAWS over the course of the inspection period.

#### The WB reply to this request is as follows:

Hello Conference Participants, As you may know, the Operational Rules of the Fellowship Intellectual Property Trust (FIPT) describe a process whereby a regional service committee can request to inspect the records and operations of the Trust. Following this cover memo are three documents related to such a request we received from a regional delegate on behalf of his region. These documents are the request from the South Florida Region dated 17 April 2017; our response dated 29 August 2017; and an Addendum, which responds directly to each of the ten Concerns listed in the request. We are forwarding these documents to all Conference participants to keep you updated on this matter and because this is an issue we expect to discuss at the 2018 World Service Conference—both this particular request and the process for making and responding to these types of requests. We apologize for the legal tone of our response and the Addendum. We would prefer never to have to consult attorneys when responding to members or service bodies. We would much rather resolve issues and concerns within the Fellowship rather than resort to legal means, but when a request involving legal matters is made of World Services, a legal response is both prudent and appropriate. As the documents that follow explain, after consulting with both our corporate and copyright attorneys, we do not believe all of the Concerns described in the request fall within the purview of a FIPT inspection. We are also awaiting confirmation from the requesting region about their specific concerns. We expect to have more to report before the 2018 World Service Conference, and we will request the guidance of the WSC. We see our role as Trustee not just as a set of legal duties, but fundamentally in terms of spiritual principles. We have been charged with a legal "fiduciary" responsibility, which, simply put, means a position of trust, and we strive to honor that spiritual ideal. Clear reporting and communication are consistent with our commitment to accountability and integrity. We would also like to have a more general conversation with the Conference about the process for requesting an inspection of the Trust. The FIPT was drafted and approved in 1993, before the restructuring of World Services. When the FIPT was approved, the budget of the World Service Office was separate from that of the World Service Conference, and not under the control of the WSC. The financial structure adopted by the Conference during the restructuring of World Services does not lend itself to a quick and easy Trust inspection. We do not segregate Trust property in this way; we organize our financials according to the policies adopted by the Conference and as described in A Guide to World Services in NA. As the FIPT is currently written, a single region can request an inspection of the records and operations of the Trust, and such an inspection can be both time-consuming and costly. We are not sure this part of the Operational Rules reflects the Conference's current thinking. A policy that allows a single region to make a decision involving the allocation of so many resources seems contrary to our evolution toward a consensus-based Conference.

This is one of those policies that we have known was outdated and unclear for some time, but have not wanted to drag the Fellowship through a detailed review. The recent inspection request, however, has made it clear we may be overdue to have this conversation.

I have included the whole packet we were sent. I found the time line very interesting as South Florida informed the World Board that their request was coming in December 2016. Giving formal request in April 2017 and the World Board finally telling all the Regions in August 24 2017.

I would also like to point out the bold print in the World Board response I did that because I believe it is not our (meaning the RD Team) place to make decisions about the FIPT. The literature and in turn the FIPT belongs to the Groups. And it is the Groups who need to response the World Board and their questions. So that is why I am boring you with all this muck because it is up to you the RCM's and the rest of the Regional Body to start having this conversations with the Groups.

- 1. 1<sup>st</sup> bold print; We expect to have more to report before the 2018 World Service Conference, and we will request the guidance of the WSC.
  - i) We will need to know what to tell the World Board hopefully they will talk to us before the Conference though we don't have any guarantees.
- 2. 2<sup>nd</sup> bold print; **We would also like to have a more general conversation with the**Conference about the process for requesting an inspection of the Trust
  - i) What does the Groups think should be the process for seeing where their money, ideas, and where their literature is going.
- 3. 3<sup>rd</sup> bold print; . We are not sure this part of the Operational Rules reflects the Conference's current thinking.

The Conference should not have been asked if "they" believe the Fellowship still affirms the rules we have agreed on in the FIPT.

4. 4th bold print; to our evolution toward a consensus-based Conference

This is the problem I see about a consensus-based Conference. We the delegates are asked to guess what the Groups think and then when the Conference makes a decision without any feedback from the Groups they (the Groups) are stuck with those decisions. Like the Conference (ie the Groups) think that the financial reporting by the NAWS is good enough. Plus the following from the third draft of the 2016 Conference page 14.

Do we believe that the Fellowship still affirms the rules we have agreed on in the FIPT?

Should we register and list on the meeting locator, NA groups that clearly intend to use material that is not NA-Fellowship approved?

Should we take action to remove NA recovery literature from ASC/RSC sites, even if it means shutting down the site? (This may require ongoing action if a new site is created.)

- i) I don't remember the last time we (the Groups) were asked about our literature since we gave it away back in the 90's, though our delegates where asked what we thought.
- 5. 5th bold print; This is one of those policies that we have known was outdated and unclear for some time, but have not wanted to drag the Fellowship through a detailed review. The recent inspection request, however, has made it clear we may be overdue to have this conversation
  - i) On page 30 of the 2016 CAR the board says "The Fellowship Intellectual Property Trust itself is written in legalese and puts most members to sleep. But it is an expression of the hard-won experience and decisions by the Fellowship in response to many of the same issues that seem to be Resurrected today. Its purpose is to ensure that NA's property is held in trust for all of NA and kept safe for members yet to come, in keeping with our primary purpose."
- 6. C.A.R. order form is out you can order a copy for \$7.50 November 29<sup>th</sup> Item 9140

If it was known was outdated and unclear for some time why was the Fellowship not informed.

Okay I will get off my soapbox though you can see why I get up on it. We the Delegate Team needs to know what our Groups think.

A quick rewind on some of the motions we have heard about;

- 1) Ohio asking about making the Service Pamphlet "Social Media and Our Guiding Principles" changed to an Informational Pamphlet
- 2) Regions in the Asian Pacific Forum asking; presented by the New Zealand Region and Australian Region
  - a) to allow a delegate from current existing Zonal Forums to be seated as non-voting participant for one conference only. Expense of those Delegates to be responsibility of the Zonal Forum,
  - b) For the Conference to come up with a shared concept and understanding of Zones and what their role in the fellowship
  - c) Zonal representation by Zones if they desire
- 3) Northern New York asking
  - a) Direct the World Board to create a project plan to revising a piece of recovery literature directly addressing Drug Replacement Therapy (DRT) and Medication Assisted Treatment (MAT)
  - b) A Service Pamphlet that states clearly the rights of groups to reprint Narcotics Anonymous recovery literature covered under the Fellowship Intellectual Property Trust and its bulletins.
  - c) To replace the first paragraph under "What kinds of literature should we use" in the Group Booklet as follows
    - i) Original Paragraph; "NA World Services produces a number of different kinds of publications. However, only NA-approved literature is appropriate for reading in Narcotics Anonymous meetings. Selections from NA-approved books and pamphlets are usually read at the beginning of an NA meeting, and some meetings use them as the core of their format. NA-approved literature represents the widest range of recovery in Narcotics Anonymous.
    - ii) Replacement Paragraph; NA World Services produces a number of different kinds of publications. However, only NA-approved literature is appropriate for reading in Narcotics Anonymous meetings, and then only NA-approved edition(s) of literature that conveys a unified message as the most current edition(s). For Basic Texts, this would be the 3rd Edition Revised and newer. Older editions of our literature as well as approval drafts, while valid in history, and while they carry a message of recovery, all carry a message that in some way or ways contradict our current edition(s) of literature and are no longer in unity with the fellowship's conscience regarding our message of recovery.

Selections from NA-approved books and pamphlets are usually read at the beginning of an NA meeting, and some meetings use them as the core of their format. NA-approved literature represents the widest range of recovery in Narcotics Anonymous. It is suggested that meetings that utilize older editions of NA-approved literature acknowledge the current editions of NA-approved literature for the sake of NA unity.

## MID-AMERICA REGIONAL PHONE-LINE POLICY AND GUIDELINES (NOV 2017)

INTRODUCTION: This Policy Guideline is intended to give clear guidance about how to manage and maintain the Mid-America Regional Phone-Line. It contains best practices, point of contact, general phone-line and information specific to our phone-line. Where specific practice and policy for a phone-line situation or event is not listed in this document, we differ to the Mid-America Regional Guidelines, Public Relations Handbook, PR Basics, A Guide To Local Services In Narcotics Anonymous, The Mid-America PR subcommittee, The Regional Service Committee and a Higher Power, in that order.

Our phone-line is an information line and NOT a hotline or crisis line. The mission and purpose of the phone-line is to provide timely and accurate information about Narcotics Anonymous in general and specifically where and when to find Narcotics Anonymous meetings in the Mid-America Region using a telephonic format. This information is made available to the general public and our membership inside and outside of the Mid-America Region.

<u>HISTORY</u>: Phone-line service began as discussion many years before fruition. At that time costs were prohibitive for a toll-free service. With the advent of relatively inexpensive internet answering services availability beginning in 2008, discussions moved toward action. After Motion # 052012-01 was ratified by the groups in 2012, construction began in 2013 and the Mid-America Phone-Line went "live" in early 2014.

#### PHONE-LINE FACILITATOR DUTIES:

Point of contact for phone-line logistics, "live-addict" volunteer recruiting and training, "live addict" volunteer shift assignments and update of phone-line information is the responsibility of the Phone-Line Facilitator. The facilitator is a conduit for information to and from the Mid-America Regional Public Relations Subcommittee. The facilitator will issue a written report to the Regional Service Committee through the Public Relations Subcommittee quarterly.

#### **ADMINISTRATION AND LOGISTICS:**

The Phone-Line Facilitator will be responsible for log-in and password information for the Answering Service, change that information when necessary and make that information immediately available to the 1) RSC Facilitator

- 2) RSC Treasurer
- 3) PR Coordinator

The phone-line currently utilizes an internet based answering service provider to provide toll-free telephonic meeting time and locations in the Mid-America Region. Regular review of this provider should be conducted by the PR subcommittee and Phone-Line Facilitator to ensure efficiency, feature availability and best use of funds. This service presently utilizes voice recordings (MP3) and typed scripts with text-to-voice technology.

## MID-AMERICA REGIONAL PHONE-LINE POLICY AND GUIDELINES (NOV 2017)

- 1. UPDATES NA Meeting location, day and time updates will be coordinated with the Mid-America Regional Meeting List Coordinator and occur not less than each RSC. Updates of "live-addict" volunteers and volunteer shifts will be reviewed not less than each RSC.
- 2. VOLUNTEER TRAINING All "live-addict" volunteers shall have a minimum of; one (1) year clean-time and active involvement in Narcotics Anonymous Service at the Regional, Area or Group Levels. All 'live-addict" volunteers will be assigned shifts of three (3) hours minimum and volunteer length of service is assumed to be one (1) quarter (RSC to RSC) minimum. All volunteers will be trained before assuming shift duties.

Training will include but is not limited to attending presentations of Phone-Line training at the RSC weekend or direct/and or remote communication, by email and/or telephone, with the Phone-line Facilitator. Training will include mock phone calls and practical examples of phone-line do's and don'ts. Present information includes excerpts from the PR Handbook, (855)732-HOPE and MID-AMERICA PHONELINE Powerpoint presentations. All "live-addict" phone-line volunteers serve at the pleasure of the Regional PR Sub-Committee and can be added or removed at the discretion of the Phone-line Facilitator.
