I email and post to our Facebook page close to RSC, so electronic and hard copy distribution happens close together, I suppose just for personal preference.

#### **Website Coordinator Report**

November 16, 2019

The RSC PR Coordinator and Website Coordinator have met several times for training and almost all ongoing changes and maintenance of the current site are being managed by the Website Coordinator. Note that updates to the Event Calendar are happening on a timely basis.

#### **New Website:**

The new website using the Internet Service Provider (ISP) inmotionhosting.com was launched in early September, prior to the expiration of the term of service at the old ISP, ipower.com. Unfortunately, iPower billed us for another 2 year period (\$368.28), on September 1, even though the renewal date was Sept 16 (see copy of receipt). Beth N and Curt S only found out this over the weekend. Curt has opened case# 18126055 with iPower to get the chard reversed

The new site uses Wordpress as its Content Management System (CMS), instead of the Drupal CMS used on the old site. As such, the new site was built from scratch. It contains all the functionality of the old site, and all of the archived records of the MAN and RSC minutes that were available on the old site. Currently, the style is much the same as the old site, but with several functional differences. Among these are:

- Google Maps integration for the Events Calendar. This provides maps directly in the Event listing.
- Auto-formatting for portable devices (smart phones, tablets, etc). When the site is opened in a phone or tablet, the format of the site is designed for use on these, and provides much faster access to pages.
- MonsterInsights/Google Analytics. This allows us to see usage data for the website including visitors, sessions, how users are acquired, time of day usage, device usage and other information.

# M Open Forum:

- John J. brought up the location for region, proposing we have a list of the things wrong with the current state of the building, to give to the city
  - A few members suggested that we step up and leave the place better than we found it each region meeting weekend. If we clean it before we leave it should be in the same state we left it, if not then we can address. We should follow up two weeks before the February RSC.
  - Discussion on the fact that the door is not locked and if we can discuss this issue with the city. Tim S. stated that keys have been an issue as they have switched maintenance people a few times during our tenure at the school. There is one key to the outside and one key to the inside.
  - Discussion on the Wifi problems: Tim S. pointed out that the daycare has wifi and we are permitted to use that wifi with their password that we have. Rod D. asked if we could find prices on routers or direct connections through the daycare router. Jeffry L. offered to take the finding of prices for next region.

on this to explain that the members putting this campout on seem to be doing everything they can to put this campout on, including foregoing the general process of getting events approved as this was not listed in any group or area minutes and cannot be traced back to a group or area supporting it. This also goes along with the description of the problems going on in the Miracle Area in the RCM's report for Miracle.

More discussion on how this is a resentment campout based on tradition violations from the previous campout committee, but these are still members of our region and if they are going to put on this campout we should be showing up and supporting them, we should never be in competition with each other, there are plenty of addicts to reach. We should also not be talking about them when they aren't here to defend themselves. It was also pointed out that this was not mentioned in the last group conscience for the group that is "supporting" it and this is some manipulation and resentment and if those members care to be here they could be. The Facilitator ended the discussion as he could not see that there was anything that the region could do, unless the area came to the region requesting help.
