h. Right now either party has 90 days to get out of our Marquette contract.

(was discussion on how passing the basket and giving that money away violates traditions as well as endorses to outside entity)

Howdy Peeps:

On April 2nd we got sent a poll asking us to vote on where we wanted to go from here. Here being lockdown and in quarantine and not being able to meet for 10 days in California. 120 out of 127 voted to

- 1. Meet virtually to decide essential business only (107 yes)
- 2. Only conduiting discussions and decisions on an emergency budget and just the project plans outlined in the 2020 CAT (106 yes)
- 3. Discussion and decision on the FIPT operational rule moratorium end date (86 yes)
- 4. Conduct elections (110 yes)
- 5. Schedule 2 sessions of 2 hours per meeting day between April 25th to May 3rd (90 yes)

Five other questions were 60% less so they did not pass.

We opened on Friday April 24th at 1:00 PM CST with a PowerPoint presentation going over the rules of engagement. Each Regional Delegate was given a number and we put that first, then our Region and last our name. (060 MidAmerica Rod D) Alternates just had our Region, AD then their name if you did not do these then you might be stuck in a waiting room if you got booted during the meeting. We used the yes, no, backwards, and forward buttons during the meeting to vote backwards meant Abstain, and Forward Present not Voting. During the second session on Friday there was question and answer time. I asked about moving the Office and got the same old song and dance. Lots of questions bout budget and money which leads me into Saturday

Lawsuit is ongoing because of the lockdown it has been postponed until June. Anthony also said we had received two complaints that I am trying to get more information about. Money has been a challenge since the lockdown nevertheless NAWS has added a new contribution link to the website that has gone from reoccurring contributors to 310

by April 22nd. And from \$2089.00 to \$8091.00 in monthly contributions. We have seen 18 newly posted translated recovery literature and service material since March. Audio Basic Text in Arabic, Hungarian, Russian is done and Spanish and English coming soon. All paper mailings have been suspended until further notice. Though they will be starting up the H&I printings back up soon (Behind the Walls, Reaching out). Meeting growth of NA was talked about United States has only grown by an average of 1% since 2008. Currently we have 35% of the meetings in the World, Iran has 34% and the rest of the World takes up the rest. The literature CAR Survey had 4557 members in 8 languages and 53 Reginal responses. I have included the handout with my report so you can see what kind of new or revised literature is being asked for.

Dear Mid-America,

A lot changed since I accepted this position. With the stay-at-home order in effect, this really changed my professional life and frankly did not have the time to dedicate to this position. I have also struggled personally with my mental health and generally I have not been as motivated as normal. I would like to publicly apologize to Rod for not dedicating the time that I would like to the WSC. I put in as much time as I could and I was only able to attend the weekend Zoom meetings for WSC. (This means I missed the Wednesday session.)

The RD report is comprehensive and I really only have general impressions to add.

My impression of the WSC is that many of the conference participants struggled with the technology. There was also great concern about the emergency budget as there was a lot of unknowns about the future.

On the final day, there was significant amount of disunity for how to continue the WSC. As mentioned in the RD report, we have a conference participants webinar coming up (June 21st) and more will be revealed how we are going to proceed based on the ePoll results. (ePoll was the compromise for the first step on how to proceed.)

My professional and personally life has started to stabilize and I plan on digging into the information and process with greater diligence.

Finally, I purchased my flight to WSC in November. After multiple contacts with Southwest airlines, there is no refund available. I do have a credit on my account but it lasts for a year right now. One of the Southwest customer service reps mentioned that the amount of time the credit will be usable will probably be extended but there is nothing mentioned on the Southwest website at this time. I can send the balance of the funds minus the airfare right away, but if I need to pay back the RSC for the airfare then I will need to make a couple payments.

🝽 Campout Guideline Policy Change

There was much discussion on changing the current policy for how the campout decides the location of the campout for the following year. Currently the policy is that the next campout location is decided at the closing meeting of the current campout. For 2020 this means that the campout committee will decide the location of the campout for 2021 at their closing meeting on the last day of the campout.

The motion was brought forth as a recommendation to change policy, so that if the motion is passed it will go back to groups that the regional policy is being requested to change. If the motion is approved it will go back to groups, with the recommendation of how the policy wording will be changed, for groups to vote on. The groups will then bring those votes back to region and it will be voted on to either pass or fail the motion to change policy. It was also discussed that the motion will not go into effect IF passed until 2021. There was further discussion on taking the decision away from the campout committee, it was mentioned that Soul to Soul is currently operating in the same way the campout is operating, bids for the next years event must be brought to the closing meeting to be voted upon by the committee and lock in the decision. While changing the policy would change when the campout location is decided it was also pointed out that currently you can only reserve GROUP camp sites 8 months in advance. Carrie E. stated that this was the case for the 2020 campout location, they could not reserve the park until January 1st of 2020 for the event on the weekend of July 4th, 2020. While Soul to Soul's policy was brought up, the policy determining Convention was also brought forth to bring up that the RSC Business Meeting makes the final decision on where the convention will be held at the recommendation of the Convention Committee following bids. Clarification was needed from the motion maker to ask where the decision would be made, in the campout meeting during RSC weekend, or during the RSC Business Meeting? The maker of the motion clarified that it was to be decided during the Business meeting on the RSC floor.

Motion: To change Regional Policy at Campout Guidelines page 13 Section 1 to the following: "Designate site or sites for the upcoming campout at the business meeting of the RSC prior (May RSC) to the Regional Campout. Dates of the event to be the weekend of/or before the 4th of July.

Intent: Under the current guidelines page 13 Campout Guideline Section 1: Designate site or sites for the upcoming campout at closing meeting of previous Campout: Dates of event to be weekend of or before 4th of July. We ask to replace the language in the spirit of rotation and to add more accessibility for Areas, unable to attend the close out meeting, to be able to place bids for next years campout, and to resemble the way the regional convention is chosen.

Approved to be sent back to groups.

Motion was read as written for clarity, a vote was taken and the motion passed 6 yes 1 no. Policy is changed.

 \bigcirc New Business:

Convention Chair: Normally the convention chair position is decided by the RSC body on the floor at the February RSC, whoever is voted in will take over the next convention as the committee cycles in April after our annual convention. Ben is asking the RCM's whether they would like Angie B. to take over the convention chair position or will we leave Ben the chair position till next year. This came in response to the committee deciding the roll over MARCNA 37 until the year 2021 and not hold a convention in the 2020 year due to the COVID-19 Crisis.

It was asked how Angie felt about the current position and what she would prefer. Angie stated that she is comfortable staying on as Co-Chair and stepping into the Chair position for Convention 38. RCM's voted, Ben will remain the chair for MARCNA 37 (2021) Angie will take over the following committee next year (April 2021) after MARCNA 37 close out meeting.

- Internet/Rent: Shelley clarified that internet was not part of our initial contract, and fellowship development is recommending that we agree to the rent change (\$100 annually) to cover the fiber optics for wifi. It was clarified that the city was asking for a minimum of \$100 to offset the cost of placing the fiber optics in the building. Much discussion on what places we have had in the past, and how, when looking for a new place to meet we talked about the fact that we need a place with internet. Shelley withdrew and said we can table this (increasing our rent payments) till next RSC. Matt M. brought out the 2018 records for the contract, as proposed, and wifi was not included in that contract.
- Paying Rent: Shelley W. stated that we should pay our rent as that is part of our contract. It was also brought up that we are still using the building as we have our storage area in that building, and we have a total of 10 days a year we can use the facility, this just means we are not using two of the days we originally planned on. It was decided we will be paying rent as normal.
- PO Box AutoPay: We were late on our payment the past three years, we could set up an autopay with the post office so we don't risk it getting shut off. The treasurer and Amber C. (filling in for PO Box) will get this set up.
- Printing Meeting Lists: We will stop printing meeting lists until we are able to meet in person. Agreed upon by all RCM's present.
- Insurance: Insurance questionnaire was mailed out by Debby S. as mentioned above. It was mentioned that this is difficult to fill out when we don't have an accurate way of reporting what groups are meeting and when because of COVID-19. Debby stated that we should fill this out to the best of our ability as a guess to see what all we "have," to make sure that we are insured on it. Much discussion on what to report, and why we are reporting. We are reporting as much as we can so that if an accident happens, we have insurance coverage on anything lost. It was brought up that Miracle Area has a fluctuating literature stockpile that could go from 7-9 thousand from month to month and how we should be looking at reporting these numbers. Debby stated that we don't need a month to month analysis to supply to the insurance company, but we need to have somebody keeping track of what we have so that if something happens and the insurance agent asks, we are able to provide them with a list of what was lost during the time of loss.
- Woiding checks: There was a check written to put on a PR to Professionals presentation, this check was written to Matt M.- Matt says to void this until the time comes that another check will be needed. We normally write a check to whoever is printing the meeting lists at Office Depot, it was assumed that we

should not print meeting lists as we have no way of passing out that information because of social distancing guidelines and how most of our meetings are not meeting in person currently- Curt S. said he will talk with Whitney, but we can go ahead and void that check out.

- Money to send Jeffry L. to WSC: Jeffry spent money on a plane ticket to prepare for the WSC, this was before the decision was made to not have an in person WSC and there are no refunds available, there is a credit on Jeffry's account but he will be using this as a personal credit and he stated that he will pay the money spent back to the region. Jeffry will be paying \$100 a month until it is paid back.
- Annual Report: As per policy we set the Prudent Reserve at the May RSC. The treasurer made the recommendation that we keep the Prudent Reserve at \$7000 and increase the quarterly escrow to \$26.50 for the PO Box payment, which is a \$1.50 increase.

BMLT move from the Texas/Oklahoma server to the Plains States Zonal Forum (PSZF) server:

While it was desired to have this completed by this RSC, it is not complete. However, we have made substantial progress. As of now, the following is complete:

- administrative credentials have been provided and tested on the PSZF server,
- all service bodies have been entered in the PSZF sandbox and production servers,
- an export was taken from the TX/OK server and provided to Barry (webservant for PSZF),
- using a specially developed script, the database export has been imported into the sand box server,
- Initial review shows the import to be successful.

Remaining to be completed:

- In-depth review of meeting data in sandbox server, along with format resolution,
- Review of meeting data in sand box server against the meeting information as provided by the meeting list coordinator,
- When those are complete, take SQL dump of the data from the sand box server and import into the production server.
- Delete the data from the TX/OK server
- Set up the BMLT satellite Wordpress Plugin on the marscna.net website.






