ARTICLE II: PARTIES TO THE TRUST

Current language:

The Fellowship of Narcotics Anonymous, as given voice by its groups through their regional delegates at the World Service Conference, is the Settlor and the Trustor. Narcotics Anonymous World Service, Inc is the Trustee of the Trust. The Fellowship of Narcotics Anonymous as a whole is the Beneficiary of the Trust.

Proposed language:

The Settlor and the Trustor is the Fellowship of Narcotics Anonymous, as given voice by its groups through their delegates at the World Service Conference (WSC). The delegates are the representative chosen by the regions and zonal's seated at the WSC. Narcotics Anonymous World Services, Inc. is the Trustee of the Trust. The Fellowship of Narcotics Anonymous as a whole is the Beneficiary of the Trust.

The World Board had a web meeting in April with 220 participants World Board Vice Chair said that normal methods of gathering information and reporting have been disrupted. So small group discussions will be focused on how to gain that overall perspective. He also wanted to remind everyone if you have any questions do not hesitate to email them at <u>wb@na.org</u>.

Anthony E your Narcotics Anonymous World Office CEO reported that the new literature income is under the amounts set as allocations in the emergency budget but is slightly improved at approximately 18% under budget. Most expenses are under budget exception of legal expenses and in house production and expensive for Accounting and Technology. Antony believes the budget for the second year will be just as speculative as year 1st year. They are expecting to have a draft to discuss at the Webinar on June 12th.

Fellowship contributions are steadily rising. In February about 50 members were donating about \$2000.00 a month and as of April's Webinar 750 are donating \$20,000 per month. Now follow closely because this gets tricky World Service Office has set themselves a long-term goal of getting 70% of the contributions for services delivered from the 7th Tradition. Services in ordinary circumstances (not global health crises) are \$5,500,000. 70% would be \$3,850,000 per year contributions are just under \$1,000,000 which would about a ¼

that is wanted. So, World Services would like to add 10,000 members to contributed \$10 a month and another 20,000 members \$20 month would help them reach their goal.

Along those lines the QR code has been fixed on the website so that members can be directed to the contributions page at www.na.org/contribute

An in-person World Service Conference is uncertain says our World Board Vice Chair Tim (remember Talia our World Board Chair has passed away) so look for a Virtual WSC once again next spring.

At last season's Virtual WSC we passed Motion V3 which acknowledged that the World Service Office and the World Board would work on projects as best they could with the resources they have. Reporting on that they say the ones lacking progress are the IP #21 The Loner, the new IP for Women, and the Issue Discussion Topics for this cycle.

The ones that are progressing is the Virtual Meetings Project, there were two open Webinars in March about how to connect Virtual Meetings to NA services. The Audio along with a report and a PowerPoint presentation has been posted on <u>www.na.org/virtual</u>. Also, they have a survey about Virtual Meetings, posted until the end of May please take it if you can.

On a different note, on October 29th, 30th, and 31st Midwest Region will be hosting a learning day about Virtual Services that maybe hybrid more will be revealed.

There is also PR Survey posted that is not being compiled by Narcotics Anonymous World Services but by some professionals who refer Addicts to our Program. On a personal note, I did not like it because they wanted to know what my drug of choice was. Yours and More were not listed.

Audio of the 5th Edition Basic Text is posted on the Website in English, Arabic, Hungarian, Russian, Thai, and finally Spanish. It is available for download or steaming at <u>www.na.org/audio</u>.

Spiritual Principle a Day Meditation Book has another set of items posted until the end of May. The final batch of review and input drafts will be posted in June and then they will be putting it all together for the Conference Agenda Report this November.

The Media page at <u>www.na.org/media</u> has Videos, PowerPoint presentations and other items so check them out.

With the Conference coming up normally the Delegate would answer questions about their Region and those would be compiled and published for everyone to read. You can find past reports at <u>https://www.na.org/?ID=wscArchive</u>. So, after the informational part of the Webinar, we broke in small groups to discuss some questions.

- 1. **The type of information to collect.** What are the things you would like to know? What are the questions you think we should be asking? Some of the answers are as follows.
 - a. What are Public Relations doing and how are they reaching out?
 - b. What is Hospital and Institutions doing and how are they reaching out?
 - c. Of course, the big one how is Virtual NA working out, are they part of the service structure.
 - i. Virtual Areas have been formed to serve Virtual Groups in Poland, Brazil, New England, Italy, Argentina, and in the US Chicago and Alabama/Northwest Florida, New England.
 - ii. And a Virtual Region has also been formed and it is beginning to look like that all began in 2014. Today they have a virtual Service Committee, Information Committee, Fellowship Development Committee, Events Committee, Public Relations Committee and an Executive Committee. See document in shareable file at bottom of this report.

17 April 2021 CP Web Meeting Script: Environmental Scanning in Times of Covid

Approximately 220 people attended the April 2021 Conference participant web meeting, including approximately 8 staff, 8 former Board members who helped administer the small-group discussion, and translators (Portuguese, Russian, and Spanish) together with Conference participants, HRP members, and a WSC Cofacilitator.

The discussion was focused on how to get a current view of the Fellowship and service system during the pandemic.

CP Topic and Small Groups question

How do we get a pulse of the Fellowship and its service system that is somewhat current? How do we get a sense of where NA is right now in the time of COVID?

Small Group Question

1. The type of information to collect. What are the things you would like to know? Or What are the questions you think we should be asking?

*How are we implementing hybrid meetings?

*How are we facilitating hybrid meetings?

*How do we ensure equity and anonymity for attendees?

* How are Newcomer finding Meetings?

2. Collecting information on a regional or zonal level. How do you plan to collect this information? Is the region in good contact with the member areas? Is the region meeting regularly enough to gather the information that way? Do you use a survey?

Financial Update

Literature sales have slightly improved to just to 18% under Emergency Budget, expecting to see a more increase this summer as needs and the World opens.

Most expenses are under budget except for legal expenses and in house production along with the allocated expenses for Accounting and Technology.

Fellowship Contributions

In February 2020, about 50 members had recurring contributions to World Services, which collectively totaled about \$2,000 a month. Now more than 750 members have recurring contributions, which add up to more than \$20,000 per month.

We have set a long-term goal that at least 70% of the funds World Services spends to deliver services will come from contributions. Under ordinary circumstances, when we are not in a global health crisis, our expense for services is approximately \$5.5 million, and 70% of that is approximately \$3,885,000 per year. Contributions were just under one million dollars in the last fiscal year, which is a little more than a quarter or 25% of the total for the goal the World Board has set.

If 10,000 members contributed \$10 per month and another 10,000 contributed \$20 per month, we would almost reach our goal. QR Code

Motion V3, passed at the last WSC, begins:

As WSC 2020 participants, we acknowledge our understanding and acceptance that all 2020-2022 project plans were created and offered before the current world crisis and public health-imposed quarantine and will only be worked on when and if the resources become available. We will consider each project plan presented for the 2020-2022 cycle on a project-by-project basis as required by current conference policy with this qualification.

Currently, we are staying focused on the Spiritual Principle a Day Meditation Book (SPAD) and Virtual Meeting Project. This is due to more the half of the staff is either furloughed or laid off.

The Loner IP: We have not started the project to revise this IP. The first step is to post a survey to collect information on what people would like to see changed in the IP, but we have not yet done that, and we may not be able to before CAR season starts.

Issue Discussion Topics: The other project that we have not really addressed is the IDT project. We had said that we were going to post a survey asking members what they would like to see in a piece of literature on NA and Drug Replacement Therapy/ Medically Assisted Treatment (DRT/MAT). But again, we may not be able to do that before the next World Service Conference.

IP for women: WSC 2020 passed a motion to create a project plan to develop an IP for women. Normally, we would have posted a survey asking members what they what want to see in such an IP. The input would help frame the project plan and begin work on the pamphlet if the motion passed at WSC 2022. But again, we have not yet posted a survey, and we are not certain we will be able to before the Conference.

Just considering the work that we have committed to and that hasn't been accomplished this cycle, the Board believes we already have a full plate for next cycle, we are not intending to undertake our normal planning process this cycle, because our attention, resources, and future work seem to already be outlined.

Board urged everyone to keep that in mind when contemplating CAR motions. We are already working at capacity, unless and until staffing levels are higher. They encouraged Regions and Zones to reach out to the Board to talk about issues that they would like to see addressed before the CAR motion deadline. Perhaps we can figure out an approach that doesn't involve a motion or another project. Sponsorship Day

Currently, Sponsorship Day happens annually on the first of December. The Board received a request from a delegate to consider changing the date because December first has, since 1988, been designated World AIDS day—an international day dedicated to raising awareness of the AIDS pandemic caused by the spread of HIV infection and mourning those who have died of the disease. The delegate explained that there had been several requests in their region for the date to be changed.

The World Board discussed the issue, and some of the points raised in their discussion were that there are so many special days and holidays around the world, it may not be possible to schedule our NA annual days without running into a conflict of some kind. And some may consider holidays and non-NA commemorative dates an outside issue. We are not trying to make an argument for or against changing the date. Conference participants have asked the Board to make these decisions on dates in the past, and now we are being asked to consider a change. Our hope as a Board is to avoid this type of issue becoming a regional motion in the CAR, and in that spirit, we are asking for your direction. These days belong to NA as a whole, so we would like them to be held on whatever dates seem to represent the desires of the Fellowship.

Delegates were then polled on the question.

Are you in favor of changing the annual date of Sponsorship Day to something other than 1 December?

Results: 27 Yes/ 26 No/ 7 Abstain/ 9 Present not Voting

The Board was just taking the temperature of the body on the issue and that the Board would report on any further discussions they have about the date.

WSC Future

Board warned Conference participants that it currently doesn't seem realistic to hold an in-person World Service Conference. International travel is very difficult right now, and the situation isn't' stable, and there's no real way of knowing when those restrictions will ease up.

The Board has not met in person in over a year, and they have no plans for an in-person meeting in 2021. Travel to the US is not practical or even possible for many international members right now. We don't know what the situation will be at the time of the Conference, but we need to make a decision soon, as there are contract and other logistical aspects at play.

Given all of that, it looks like we may have another virtual WSC in 2022, and it seems wise for everyone to start thinking about what another virtual WSC might look like and how that affects our preparation.
