Hey family.

What an awesome convention that was just experienced by a lot of people. Thank you for allowing me to be a part of and to be a trusted servant for NA and this region. It was one heck of a journey and the committee really worked together to make it happen. They worked hard and by the success of the convention, we all should be able to agree on this. Kudos to the folks who were not part of any subcommittee but stepped up to assist others in helping with the convention Service work is a must!

The State rollcall we had on Saturday night was exciting to see the various states that were represented. The clean time count down with an addict having 50 years and an addict with less than 24 hours clean were truly blessings. The newcomers receiving a basic text and/or it works how and why books that were donated from homegroups was totally heart touching. We had 5266 years and 5 months that were recorded. All of us played a part in this celebration of recovery! The speakers did a fantastic job and workshops were heavily attended and enjoyed

by everyone who attended. I received a lot of feedback regarding this. Thanks, Rich C. for your service in putting together a good lineup.

Our merchandise vendors, tape man and photographer were very generous in their donations and all of them were anxious to be involved for our next one too. The photographer was a new thing we did this year and was enjoyed and utilized by a lot of folks.

The memorial video that our Arts & Graphic chair, Mike G., created was a hit as well. We hope that everyone will send in their photos for next year's convention.

Our Archivist, Tim S. brought the history alive at the convention and so many folks were amazed to see all the memorabilia and hear Tim's stories about our history. We appreciate your service Tim.

We had great feedback regarding our hospitality room. The hospitality folks were welcoming and working hard to keep everything available for everyone. We had to work out a major issue in getting everyone to the Hospitality penthouse but we made it happen!!

We had a lot of activities going on with Fundraising & Entertainment and boy did they make it happen. The entertainment was enjoyed by a lot of folks and the auction brought in some great NA items to be auctioned off. Great job Ron & Travis and everyone else who played a part.

We did pretty good with our MARCNA merchandise and our Merchandise Chair, Randy, was steadily working in his space. We ordered more shirts that had "Wichita' on them but the shirt was pretty basic and was not a huge success. The prior merchandise that had been ordered sold more because of the design and theme. We will be passing on the unsold items for future convention fundraising events. Thanks for the folks who stepped up and helped in this area.

Thanks to Zac T. & Tim S. for staying close by to assist me and our co-chair/treasurer. Your service was very much appreciated.

The sub-committee chairs have brought back all necessary items for storage, and it has been inventoried. I have to say that I have done years of convention work and this by far has been the most amazing one! To be involved with this committee and to see them step up to the plate should please everyone in this region. History was made and hopefully never again will we have to experience a time lapse between conventions. A lot of the members are continuing for the next MARCNA and due to the excitement, that was brought at the convention, we have new ones wanting to step up and be of service.

Great job to our Secretary, Niki, who created an awesome excel spreadsheet for the auctions and for helping in a lot of areas wherever she could be of service.

Much appreciation to all which includes general members who were available Thursday evening to help with getting registration setup.

My special thanks to my co-chair, Shelley W., who was awesome in assisting me and giving me love and support throughout. I am deeply grateful!

We did an "Early Bird" registration on the Sunday of the convention and had a great turnout for this. We had 64 early birds and made \$640 to go towards MARCNA 38.

We had secured 100 gallons of coffee to be set out on Friday night, Saturday night & Sunday morning. There was some misunderstanding and there was 12 gallons of coffee brought up for the Saturday mid-day speaker. I discussed this with Charlotte at the hotel and their staff should have referred to the notes regarding the coffee, but this committee member should have asked me or the co-chair in lieu of the staff. We had already discussed this within our scheduled meetings about the set-up of coffee. We agreed to be responsible for half of that cost and the hotel for the other half. After receiving the final invoice from the hotel, we ended up receiving a refund in the amount of \$1440.98.

The hotel served our needs, and the hotel staff were very gracious. The banquet meal was superb and was a breath of fresh air to be able to kick back for a bit and fellowship. We did not have any complaints towards us from the hotel and after working closely with them, we know

what to expect for the next two years during our planning stages and actual events. After paying our hotel and other miscellaneous items, we made a total of \$26,596.66.

MARCNA 38 will receive seed money of \$7500 and \$640 from the early bird registrations. We will turn over to region the remaining amount of \$15,256.66. We will also be turning over cd's of our convention main speakers and workshop speakers to region that were given to us by our Tape man, Rodney B., at the end of convention.

Today, we as a committee have some valid concerns that were discussed at our closing meeting on Sunday of the convention. We would like to address them on the floor today, regarding the registration chair, Michelle L.

The issues are noted below as follows:

1. The registration chair was not present at the hotel @ 6pm on Thursday night to set up room and did not take the lead with stuffing registration bags. We had several volunteers who at 6pm but eventually had to leave. The chair did not arrive until 9:30ish. The registration chair did not apologize nor really assisted in helping with the assembly of the bags.

2. The registration chair had not inventoried the new items prior to arriving to the convention. There were not the proper number of badges that we were advised were ordered and we had to much of other items. We have requested invoices of these items prior to the convention in our regularly scheduled meetings and have yet to receive all invoices.

3. The registration chair was not prepared prior to convention with informational lists to provide to the volunteer workers to assist them in an efficient matter.

4. The registration chair had assisted in obtaining volunteers right before convention. A lot of the workers were not prepared to take on such a task. We heard a lot of flak from the volunteers who were very unhappy and discouraged by the chaos and having to put in more time than they had signed up for. The registration chair was not present in the room several times and it was the blind leading the blind.

5. The registration chair recruited a volunteer from another 12-step program and referred to them as her co-chair. I addressed this with the chair and the volunteer stepped to me for a private conversation as well and I explained to them the importance of NA members doing NA service work. This individual was very helpful and remained helping but in no way was considered a co-chair.

6. Banquet tickets were passed out to various people who had not pre-registered nor purchased a banquet ticket. We had to handle the entry of the people attending the banquet in a different manner due to this fiasco.

7. The registration chair was brewing coffee in the convention area that was totally against the hotel contract. All committee members were aware that this was not permissible. I advised the registration chair to remove the coffee pot but to come back and find it brewing under a table. I advised her again and I returned later, and it was still there brewing. Myself and another committee member removed it from the room.

8. The co-chair and I were responsible for locking and unlocking rooms. The registration chair was aware of this situation but took upon herself to ask the hotel staff to unlock her room in lieu of asking the co-chair or myself. The room was unlocked at times and left unattended. I also addressed this situation with the hotel event planning manager regarding their staff.

9. The registration chair failed to be available on time and closed the room when it was to be open per the hours reflected in the program.

10. The new pre-reg shirts were not what the committee agreed upon and when the shirts were picked up by the registration chair, she did not address this with the vendor either. Our co-chair, Shelley W. and acting treasurer contacted this vendor regarding these circumstances. The vendor gave us a credit but we were not pleased with the credit and to find out that they sub-contracted out the shirts too.

11. The registration chair sold pre-reg items at a discounted price and lied when confronted about it. These were items that had been paid for already and ended up being sold at a discounted price. She went to that person's room and gave their money back after hearing those folks were talking about it. We were told by other individuals of items being sold to them and monies being pocketed.

12. The registration chair asked the same individual who she referred to as her co-chair to secure her a hotel room. That person trusted the registration chair but due to the situation not presenting itself properly, that individual ended up pulling her card for that room.

13. The convention committee entrusted this individual with their money to purchase a gift for me. The gift that was to be given was not received prior to the convention. The registration chair was confronted about it but her response was vague. We did find out that she went to the vendor after the convention to provide him with some more money but at that time it was mute.

14. The registration chair did not attend our wrap up meeting on Sunday at the convention. She did not leave a closing report either. We are still waiting on registration information forms and are not able to secure an exact amount of what was made &/or mishandled.

As chair of this committee, I am saddened to say, I am disheartened by this individual's disrespect, defiance, distrust, and lack of organizational skills. We gave benefit of the doubt several times regarding excuses that were given when tasks were not completed as requested. This individual indicated they would not be here today and wanted to know our concerns. I did not share these concerns with this individual because this individual has held this position several times and other positions too. This individual is totally aware of their duties of this position and if needed to be told about it, is a blatant disregard of their behavior and actions. Several times throughout the planning stages, it was advised to have invoices and information, but this was always lacking and/or late. The plethora of circumstances over the weekend became very discouraging. The majority of the committee members were aware of what was taking place, but I applaud the remainder of the committee members in being diligent and responsible wherever needed. We all have a responsibility to this program in all areas of our lives. Being on this committee it became very clear and evident that the registration chair is not a trusted servant.

Life on life's terms does show up for all of us at any given moment but we as a committee have seen this reoccurring with the registration chair consistently. The literature indicates that we are each other's eyes and ears and need to hold each other accountable. The committee pulled together even tighter to ensure the convention ran as smoothly as possible.

I do not take pleasure in any of this but being a trusted servant and chair of this committee, I have a responsibility. After much discussion with this committee, we all are on the same page and agreement with these findings. We feel it is necessary to be honest and transparent regarding these very important matters. We feel that this individual is incapable of holding any trusted servant position(s) currently.

NA is a solution-oriented program and has provided us all with solutions when willing to take ownership of the problems.

Thank you for the opportunity to serve and I welcome Shelley W. in as chair for MARCNA 38!!

Hello family We accomplished a lot yesterday in our opening meeting. We had people step up for service positions but still need some people willing to help put on a kick bootie convention. Positions available are Co-secretary, Treasurer and Co-treasurer, Co-Entertainment, Hospitality, co-hospitality, Co merchandise,



Registration, and co-registration. Please take back to your groups and we always need general members as well!!!

Our interim meetings will be held at 3735 West Douglas in Wichita Kansas at 1pm on the 3rd Sunday of the month in June, July, Sept, Oct, Dec, March and in January we will have our meeting at the hotel. Our interim meeting will be available via zoom- that information will send out on Mid-America as soon as we figure out if we are utilizing Zonal zoom or the same one, we used last year!! Region weekends we meet at 1:30 in Marquette Kansas on Saturdays.

Our theme for 2023 will be "Reflections of the spirit" and some artwork was picked!!! More to be revealed.

A save the date flyer will be out soon. I will also get word out when the rooms will be available to reserve.

The committee decided that square terminals would be a wonderful addition to accept payments that way we are not tying up people's phones/tablets and in this day and age of plastic being used it only makes sense Square fees are a little less than PayPal. We utilized both at this last convention. Motion- to purchase 5 square terminals which are 299.00 plus tax (2 for registration, 1 for entertainment, 1 for fundraising and 1 for merchandise- for up to 1700.00. M/S/P.

The committee also made a decision that due to the rising cost of inflation at this time that it would be prudent to increase our seed money to 9000.00- a motion was made, and this passed as well.

WE also gave our fundraising chair \$600.00 to kick off his efforts of purchasing items for fundraising.

**Since we do not have a treasurer yet..** This is where we sit with that account. We had taken in 64 pre-registrations at the convention. So, with our 9000.00 seed money, the 640.00 pre-registration money- less the 600.00 for fundraising and the 1700.00 setback for square terminals our treasurer balance of today is 10740.00

Campout at this time had no way to accept cards- so they borrowed convention PayPal last night and that money was deposited, and a check was written to camp-out committee, (This is for transparency in the checkbook.) 695.98

There are new changes with the Office Max/Depot discount program we have been using, as of May 1<sup>st</sup> a new company took over the program called ODP Business Solutions. Don S. from San Diego is currently working on a new contract with them, and the card we now carry is no longer valid. I was able to get the discount this printing, thru miscommunication.

The cost for 500 newsletters printed, folded, and stapled was \$158.96. I called Salina's Office Max and found out the order was almost done, they just needed to staple them. I was also informed they accidentally printed in color and the Manager was going to give us them at the B/W price, which was already paid. When I got the call that they were ready, I discovered they trashed the color run and reprinted in B/W. I asked what happened to the color run, since we were told we were getting them, finally the print manager carried up a total of 80 stapled and 291 unstapled color booklets, that were "gently" laid in the trash. I have divided these amongst the areas, along with their normal stack of B/W. Since the unstapled copies are great for H&I, I will be mailing the Hole in the Wall group a stack.

The price we paid is still below the budgeted amount, and we can only wait to see what discounts we will receive with the new contract, though the new standard is a straight 30% discount. I am suggesting that the request for funds remain the same, or “up to \$350.00”.

### **Technology roadmap**

- ASC confirmation of meetings. We ask each Area to continually review their meeting information on the regional website and report any adds, deletions, or changes for the meeting information. Our mutual goal is to have one single database that will be used by all. Please have whoever is responsible in your Area for meeting information contact either Curt or Mike so that we can establish a best practice in keeping this information updated.
- Area meeting guides from BMLT: We can extend the ability to each Area to utilize the BMLT server with Bread plugin to create area meeting lists. Again, the idea is to have a single source of meeting information so that the Regional and Area guides are always in sync. NOTE: Some printable Area meeting guides we have are more than 2 years old. Utilizing BMLT can prevent this from occurring!
- Commerce platform plugin: We currently use PayPal buttons to implement commerce pages. We have implemented and are testing the Woo Commerce platform.
